BE it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

1. This Act may be cited as the Kadawalagedara Purana Siddhasthana Wardhana Society (Incorporation) Act, No.

2. From and after the date of commencement of this Act, such and so many persons as are members of the Kadawala-

4. The Corporation shall have the power to do, perform powers of and execute all such acts, matters, and things whatsoever, Corporation. as are necessary or desirable for the promotion or furtherence of the objects of the Corporation or any one of them

General

- (1) The affairs of the Corporation shall, subject to the rules in force for the time being of the Corporation, be administered by a General Council consisting of such number of persons to be elected in accordance with the rules in force for the time being of the Corporation.
- (2) The first General Council of the Corporation shall be the members of the General Council of the Association holding office on the date of the coming into operation of this Act.
- Board of There shall be established a Board of Trustees, con-Trustees. sisting of such number of persons as set out in the rules in force for the time being of the Corporation, for the purpose of advising the Corporation on matters relating to planning and finance.
- 7. (1) It shall be lawful for the Corporation, from time Rules of the to time, at any general meeting of the members and by a Corporation. majority of votes, to make rules for the admission, withdrawal or expulsion of members; for the conduct of the duties

of the General Council and of the various officers, agents and servants of the Corporation; for the procedure to be followed in the transaction of business; and otherwise generally for the management of the affairs of the Corporation and the accomplishment of its objects. Such rules when made may, at a like meeting, be altered, added to, amended or cancelled, subject however to the requirements of subsection (2).

(2) No rule of the Corporation for the time being in force nor any rule which may hereafter be passed shall be altered, added to, amended or cancelled except by a vote of two-thirds of the members present and voting at a general meeting of the Corporation:

Provided, however, that such alteration, addition, amendment or cancellation shall have been previously approved by the General Council.

- (3) The rules of the Association in force at the time of coming into operation of this Act shall be deemed to be the rules of the Corporation made under this section.
- (4) All members of the Corporation shall be subject to the rules in force for the time being of the Corporation.
- 8. All debts and liabilities of the Association existing at the time of coming into operation of this Act, shall be paid by the Corporation hereby constituted, and all debts due to, and subscriptions and contributions payable to the Association shall be paid to the Corporation for the purposes of this Act.
- 9. The seal of the Corporation shall not be affixed to any instrument whatsoever except in the presence of two of the members of the General Council, who shall sign their names to the instrument in token of their presence, and such signing shall be independent of the signing of any person as a witness.
- 10. The Corporation shall, subject to the rules in force for the time being of the Corporation, be capable in law to acquire and hold any property, movable or immovable, which may become vested in it by virtue of any purchase, grant, gift, testamentary disposition or otherwise, and all such property shall be held by the Corporation for the purposes of this Act and subject to the rules in force for the time being of the Corporation, with full power to sell, mort-

gage, lease, exchange or otherwise dispose of the same.

Borrowing powers.

11. It shall be lawful for the Corporation to raise funds for the accomplishment of its objects and for such purpose to create, execute, grant or issue any mortgages, bonds or obligations:

Provided that the aggregate of the amounts which may be so raised by the Corporation shall not exceed the sums determined by the General Council.

Reimbursement. 12. The Corporation shall reimburse any member, officer, agent or servant of the Corporation to the extent of payments bona fide made by such member, officer, agent or servant of the Corporation, on behalf of the Corporation and for its benefit.
