AN ACT TO AMEND THE AIR FORCE ACT

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows :—

1. This Act may be cited as the Air Force (Amendment) Act, No. 9 of 1993. Short title.

2. Section 27 of the Air Force Act (hereinafter referred to as the “principal enactment”) is hereby amended by the addition immediately after paragraph (aa) of that section, of the following new paragraph :— Amendment of section 27 of Chapter 359.

“ (aaa) (i) in respect of any period during which he is suspended from the exercise of his office pending the conclusion of judicial or disciplinary proceedings instituted against him in respect of a prescribed offence, all pay and allowances, and

(ii) in respect of each month of any period during which he is suspended from the exercise of his office pending the conclusion of judicial or disciplinary proceedings instituted against him in respect of any other offence, such part of his pay and allowances for that month as may be prescribed ;”.

3. Section 28 of the principal enactment is hereby amended in subsection (1) of that section as follows :— Amendment of section 28 of the principal enactment.

(1) by the addition, immediately after paragraph (aa) of that subsection, of the following new paragraph :—

“ (aaa) (i) in respect of any period during which he is suspended from his duties pending the conclusion of judicial or disciplinary proceedings instituted against him in respect of a prescribed offence, all pay and allowances, and

(ii) in respect of each month of any period during which he is suspended from his duties pending the conclusion of judicial or disciplinary proceedings instituted against him in respect of any other offence, such part of his pay and allowances for that month as may be prescribed ;” ; and

(2) in proviso (i) of that subsection, by the substitution for the words “ the total amount of such deductions ”, of the words “ the total amount of such deductions, authorised by paragraphs (a), (aa), (aaa) (ii), (b), (c), (d), (e), (f) and (g) of this subsection ”.

4. In the event of any inconsistency between the Sinhala and the Tamil texts of this Act, the Sinhala text shall prevail.
