Minuwangoda Sinha Foundation (Incorporation)

AN ACT TO INCORPORATE THE MINUWANGODA SINHA FOUNDATION

WHEREAS a Foundation called and known as the Preamble. "Minuwangoda Sinha Foundation" has heretofore been established in Sri Lanka for the purpose of effectually carrying out and transacting all objects and matters connected with the said Foundation according to the rules agreed to by its members:

AND WHEREAS the said Foundation has heretofore successfully carried out and transacted the several objects and matters for which it was established and has applied to 10 be incorporated and it will be for the public advantage to grant the application.

BE it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

- 1. This Act may be cited as the Minuwangoda Sinha Short title. 15 Foundation (Incorporation) Act, No. of 2011.
- 2. From and after the date of commencement of this Incorporation Act, such and so many persons as presently are the members of the of the "Minuwangoda Sinha Foundation" (hereinafter Sinha referred to as the "Foundation") or shall hereafter be admitted Foundation. 20 as members of the Corporation hereby constituted, shall be a body corporate (hereinafter referred to as the "Corporation") with perpetual succession under the name and style of the "Minuwangoda Sinha Foundation" and by that name may sue and be sued with full power and authority 25 to have and use a common seal and to alter the same at its pleasure.

- 3. The general objects for which the Corporation is General constituted are hereby declared to be-
- (a) to assist individuals, families and communities in disadvantaged circumstances; 30

- (b) to assist families of workers, farmers and such other persons which have become indigent due to loss of employment, illness, disability, death or other causes;
- 5 (c) to advise and assist workers who have voluntarily resigned, retired or returned from foreign employment with regard to the management of their savings or establishment of small or medium scale enterprises;
- 10 (d) to provide counselling and assistance to families of foreign employed workers to promote the wellbeing of such families;
- (e) to assist workers who have lost employment due to closure of enterprises, retrenchment, redundancy or other cause to engage in self-employment or secure other employment;
 - (f) to provide counselling and assist workers and families to settle problems and claims in employment or in domestic environment;
- 20 (g) to provide counselling services for persons having psychological difficulties;

- (h) to provide or arrange to provide vocational training and assistance to disadvantaged young persons to engage in self-employment or to secure other employment;
- (i) to provide or assist in providing or improving houses for families in disadvantaged circumstances;
- (j) to promote public health with special emphasis on the improvement of the nutritional status of disadvantaged women and children;

- (k) to take steps to discourage smoking, alcohol, drug addiction and to rehabilitate who are subject to such addiction;
- (l) to promote the protection and improvement of the 5 environment:
 - (m) to carry out such other acts in the opinion of the Board of Management of the Corporation as are necessary, conducive or incidental to the attainment of the aforesaid objects.
- 4. Subject to the provisions of this Act, and any other Powers of the written law, the Corporation shall have the power to —

(a) acquire, hold or take any immovable property for the Corporation or give on lease or hire, mortgage, pledge, sell, exchange or otherwise alienate, encumber or dispose of any immovable property of the Corporation;

- (b) enter into and perform or carry out whether directly or through any officer or agent authorized in that behalf by the Corporation, all such contracts or agreements as may be necessary for the attainment of the objects or the exercise of the Corporation;
 - (c) accept gifts, donations and bequests in cash or in kind;
- (d) advance or lend and borrow money for the 25 purposes of the Corporation in such a manner and upon such security as the Corporation may think fit;
- (e) invest its funds, create and administer Trusts and to maintain current, diposit and savings accounts in 30 any bank;

- (f) publish or cause to be published books, journals, magazines and other literature and establish and maintain libraries, books shops and priniting presses;
- 5 (g) appoint, employ, transfer, exercise disciplinary control over officers and servants required for the carrying out of the objects of the Corporation and to prescribe their terms and conditions of service and dismiss such officer; and
- 10 (h) generally do all such other acts and things as are necessary for and incidental or conducive to the carrying out of the objects of the Corporation.
- 5. (1) The affairs of the Corporation shall subjects to Management the rules of the Corporation, to be made under section 6 of of the affairs the fact be administered by a Board of Management of the Corporation. (hereinafter referred to as "the Board") consisting of the Chairman, the Vice Chairman, the Secretary, Assistant Secretary, the Treasure, Assistant Treasure and fifteen other members elected or appointed in accordance with the rules 20 of the Corporation.

- (2) The First Board of the Corporation shall be the Board of Management of the Foundation holding office on the day preceding the date of commencement of this Act.
- 6. (1) It shall be lawful for the Corporation, from time to Rules of the 25 time, at any general meeting and by a majority of not less than two-third of the members present and voting to make rules not inconsistent with the provisions of this Act, or other written law, for all or any of the following matters:—

- (a) admission, withdrawal or expulsion of members;
- 30 (b) the election of the office-bearers, the resignation from, or vacation of or removal from, office of, office bearers and their powers, conduct and duties;

- (c) the election of the members of the Board and its powers, conduct and duties and the terms of office of the members of the Board and the filling of vacancies of the members of the Board;
- 5 (d) the powers, conduct, duties and functions of the various officers, agents and servants of the Corporation;
- (e) the procedure to be observed for the summoning and holding of meetings of the Board, the times, 10 places, notices and agenda of such meetings, the quorum therefore and the conduct of business thereat:
 - (f) the administration and management of the property of the Corporation; and
- 15 (g) generally, for the management of the affairs of the Corporation and the accomplishment of its objects.
 - (2) Any rule made by the Corporation may be amended, altered, added to or rescinded at a like meeting in like manner as a rule may be made under subsection (1).
- 20 (3) The members of the Corporation shall be subject to the rules for the time being of the Corporation.
- 7. The Seal of the Corporation shall not be affixed to Seal of the any instrument whatsoever, except in the presence of the Corporation. Chairman and either the Secretary or the Treasurer who shall 25 sign their names to the instrument in token of their presence, and such signing shall be independent of the signing of any

9. (1) The Corporation shall have its own fund and all Fund of the 5 moneys heretofore or hereafter received by way of gift, Corporation. bequest, donations, subscription, contribution, fees or grants for and on account of the Corporation shall be deposited to the credit of the Corporation in one or more banks as the Board shall determine.

- 10 (2) There shall be paid out of the fund, all sums of money required to defray any expenditure incurred by the Corporation in the exercise, performance and discharge of its powers, duties and functions under this Act.
- 10. (1) The financial year of the Corporation shall be Audit and Accounts. 15 the calendar year.
 - (2) The Corporation shall cause proper accounts to be kept of its income and expenditure, assets and liabilities and all other transactions of the Corporation.
- (3) The accounts of the Corporation shall be audited by a 20 qualified auditor.

In this section "qualified auditor" means —

- (a) an individual who being a member of the Institute of Chartered Accountants of Sri Lanka or of any other institute established by law, possesses a certificate to practice as an Accountant issued by such institute; or
- (b) a firm of Accountants each of the resident partners of which being a member of the Institute of Chartered Accountants of Sri Lanka or of any other 30 institute established by law, possesses a certificate to practice as an Accountant issued by such institutes.

11. If upon the dissolution of the Corporation, there Property remains after the satisfaction of all its debts and liabilities, remaining on any property whatsoever, such property shall not be distributed among the members of the Corporation, but shall 5 be given or transferred to some other Institute or Institutes having objects similar to those of the Corporation and which is or are by the rules thereof prohibited from distributing any

- income or property among its members. Such Institute or Institutes shall be determined by the members of the 10 Corporation at or immediately before the dissolution of the Corporation.
 - 12. Nothing in this Act contained shall prejudice or Saving of the affect the rights of the Republic or of any body politic or rights of the corporate.
