AN ACT TO INCORPORATE THE NIMAL SIRIPALA DE SILVA FOUNDATION

WHEREAS a Foundation called and known as the "Nimal Preamble. Siripala de Silva Foundation" has heretofore been formed in Badulla for the purpose of effectually carrying out and transacting the objects and matters connected with the said 5 Foundation according to the rules agreed to by its members:

AND WHEREAS the said Foundation has heretofore successfully carried out and transacted the several objects and matters for which it was established, and has applied to be incorporated and it will be for the public advantage to grant such application;

BE it therefore, enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

- **1.** This Act may be cited as the Nimal Siripala de Silva Short title. Foundation (Incorporation) Act, No. of 2012.
- 2. From and after the date of commencement of this Act, such and so many persons as now are members of the "Nimal Siripala de Silva Foundation" (hereinafter referred to as the "Foundation") or shall hereafter be admitted as members of the Corporation hereby constituted, shall be a
 20 body corporate with perpetual succession, under the name and style of the "Nimal Siripala de Silva Foundation" (hereinafter referred to as the "Corporation") and by that name may sue and be sued in all courts with full power and authority to have and use a common seal and to alter the
 25 same at its pleasrue.
 - **3.** The general objects for which the Corporation is General objects of the constituted are hereby declared to be:—

- (a) to give assistance, prizes and scholarships to needy school children and youth to enable them to continue their education, assist them in their educational, cultural and scientific activities and to establish permanent and mobile libraries;
- (b) to organize seminars, workshops, lectures, exhibitions, competitive tests and educational tours with a view to promoting the educational activities of school children and youth and to hold competitions and training camps in order to improve their sports skills and artistic skills and to take steps, including the award of prizes and certificates and giving assistance for local or foreign tours to talented children;
- 15 (c) to train persons for leadership and to utilize the youth labour for the welfare of the public;
 - (d) to take the necessary steps to promote artistic creations, sports skills and technical knowledge of school leavers and to set up vocational training centers as well as give them assistance to persue studies in computer science and technology and to establish institution to provide such study;
- (e) to assist by granting scholarships to students selected to universities and technical colleges and to establish self-employment opportunities for unemployed youth and to provide loans and to inaugurate various savings schemes;
- (f) to inaugurate and maintain pre-schools for early childhood development of the poor children, inaugurate and maintain classes in various languages and various subjects for elders, school children, school leavers and provide them with other facilities;

(g) to provide lands and houses to families who do not own lands and houses, inaugurate water supply schemes in areas where there is a shortage of water, take steps to prevent and minimize natural disasters provide buildings to schools with less facilities and to cater to other needs of such schools and provide infrastructure facilities such as roads, electricity and health in various areas:

- (h) to assist in the development of educational religious, cultural, aesthetic, sports and scientific 10 facilities without any reference to race, religion or caste and to conduct various festivals and competitions;
- (i) to provide medical relief and food for the poor, destitute and sick persons, establish and maintain 15 houses for displaced persons and elders and establish and maintain children's homes and day care centers for children and elders;
- (j) to promote, arrange and organize exhibitions, lecturers, seminars, discussions, workshops, debates, 20 panel discussions, tours, pleasure trips or such other activities with a view to accomplishing the objectives of the Corporation and to print, publish and distribute such books, journals, bulletins and newspapers are necessary to achieve these objects; 25
 - (k) to provide facilities for the blind, deaf, dump, disabled, aged and displaced persons and dump by the establishment and maintenance of houses; and
- (l) to liaise and co-ordinate with other local or foreign institutions which have similar objects. 30
 - (1) The affairs of the Corporation shall, subject to Management the other provisions of this Act and the rules in force for the of the of the time being of the Corporation, be administered by a Board Corporation

of Directors consisting of Chairman, Vice Chairman and a Secretary, Assistant Secretary, Treasurer and another nine more members elected in accordance with such rules.

- (2) The first Board of Directors of the Corporation shall consist of the members of the Board of Administration of the Foundation holding office on the day immediately preceding the date of commencement of this Act.
- (3) A member of the Board of Directors other than the Chairman shall unless he vacates his office earlier by death 10 or resignation, hold office for a period of four years. Where due to death or resignation a vacancy occurs in the Board of Directors, a new member shall be appointed to fill such vcancy and such a new member shall hold office for a period of four years.
- 15 Subject to the Provisions of this Act, and any other General written Law, Corporation shall have the power to:-

powers of the Corporation.

- (a) acquire, hold or take any movable or immovable property for the Corporation or give on lease or hire, mortgage, pledge, sell, exchange or otherwise alienate, encumber or dispose of any immovable 20 property of the Corporation.
- (b) enter into an perform or carry out whether directly or through any officer or agent authorized in that behalf by the Corporation all such contracts or agreements as may be necessary for the attainment 25 of the objects or the exercise of the powers of the Corporation;
 - (c) accept gifts, donations and bequests in cash or in kind;

- (d) advance or lend and to borrow money for the purpose of the Corporation in such manner and upon such security as the Corporation may think fit;
- (e) invest its funds, create and administer Trusst and to 5 maintain current, deposit and savings accounts in any Bank;
 - (f) publish or cause to be published books, journals magazines and other literature and establish and maintain libraries, book shops and printing presses;
- 10 (g) appoint, employ, transfer, exercise disciplinary control over officers and servants required for the carrying out of the objects of the Corporation and to prescribe their terms and conditions of service and dismiss such officers; and
- 15 (h) generally do all such other acts and things as are necessary for and incidental or conducive to the carrying out of the objects of the Corporation.
- 6. (1) It shall be lawful for the Corporation, from Rules of the time to time, at any General Meeting of the members and by Corporation. 20 a majority of not less than two-thirds of the members present and voting to make rules not inconsistent with the provisions of this Act or any other written law, on all or any of the following matters:-

- (a) the admission, resignation or expulsion of members; 25
 - (b) the election of the office-bearers, the registration from, or vacation of or removal from office of officebearers and their powers, conduct and duties;
- (c) the election of the members of the Board of Directors and its powers, conduct and duties and the terms of 30 office of the members of the Board of Directors and

the filling of vacancies of the members of the Board of Directors;

- (d) the powers, conduct, duties and functions of the various officers, agents and servants of the Corporation;
- (e) the procedure to be observed for the summoning and holding of meetings of the Board of Directors the times, places, notices and agenda of such meetings, the quorum therfore and the conduct of business thereat:
- (f) the administration and management of the property of the Corporation; and
- generally, for the management of the affairs of the Corporation and the accomplishment of its objects.
- (2) Any rule made by the Corporation may be amended, altered, added to or rescinded at a like meeting and in like manner as a rule made under subsection (1).
 - (3) Every member of the Corporation shall be subject to the rules of the Corporation.
- 7. All debts and liabilities of the Foundation existing Debts due by on the day preceding the date of commencement of this Act and payable shall be paid and discharged by the Corporation hereby to the constituted and all debts due to, subscriptions and foundation. contributions payable to the Foundation on that date shall

- 25 be paid to the Corporation for the purposes of the Act.
- 8. (1) The corporation shall have its own fund and all Fund of the moneys heretofore or hereafter to be received by way of gifts, Corporation. bequest, donations, subscription, contributions fees or grants for and on account of the Corporation shall be deposited to 30 the credit of the Corporation in one or more banks as the Board of Directors shall determined.

- (2) There shall be paid out of the fund, all sums of money required to defray any expenditure incurred by the Corporation in the exercise, performance and discharge of its powers, duties
- 35 and functions under this Act.

9. The Corporation shall be able and capable in law, to Corporation acquire and hold any property both movable or immovable may hold which may become vested in it by virtue of purchase, grant movable and movable and lease, gift, testamentary disposition or otherwise, and all such immovable. 5 property shall be held by the Corporation for the purposes of this Act, and be subject to the rules in force for the time being of the Corporation and the Corporation shall have full power to sell, mortgage, lease, exchange or otherwise dispose of the same.

10. No member of the Corporation shall for the purpose Limitation of 10 of discharging the debts and liabilities of the Corporation or liabilities of for any other purpose be liable to make any contribution members. exceeding the amount due from such member as membership fees.

15 11. If upon the dissolution of the Corporation, there Property remains after the satisfaction of its debts and liabilities any remaining property whatsoever, such property shall not be distributed dissolution. among the members of the Corporation, but shall be given or transferred to some other institution or institutions having 20 objects similar to those of the Corporation and which are by the rules thereof prohibited from distributing any income or property among their members. Such institution or institutions shall be determined by the members of the Corporation at, or immediately before the time of the

25 dissolution.

- 12. (1) The Board of Directors of the Corporation shall Accounts and cause proper accounts to be kept of all money received and audit. expended by the Corporation.
- (2) The financial year of the Corporation shall be the 25 calendar year.
 - (3) The accounts of the Corporation shall be examined and audited at least once in every year by an auditor or auditors appointed by the Board of Directors.

- 13. The seal of the Corporation shall not be affixed to Seal of the any instruments whatsoever except in the presence of the corporation. Chairman and one other member of the Board of Directors, who shall write and sign their names to the instrument in token of their presence and such signing shall be independent of the signing of any person as a witness.
 - 14. Nothing in this Act contained shall prejudice or affect Saving of the the rights of the Republic of any body politic, corporate or of Republic and any other persosn.
