*STATEMENT OF LEGAL EFFECT*

*Clause 2* : This clause amends section 2 of the Local Authorities Filling of Vacancies (Special Provisions) Act, No. 30 of 2013, by the repeal of the proviso to that section and it is consequential to the amendments made to subsection (4) of section 66B of the Local Authorities Elections Ordinance (Chapter 262) and the legal effect due to such repeal will be to revert back to the procedure followed by the Municipal Council, Urban Council or Pradeshiya Sabha, prior to such amendment when re-submitting a budget or supplementary budget to the Municipal Council, Urban Council or Pradeshiys Sabha, as the case may be.

AN ACT TO AMEND THE LOCAL AUTHORITIES FILLING OF VACANCIES  
(SPECIAL PROVISIONS) ACT, NO. 30 OF 2013

BE it enacted by the Parliament of the Democratic Socialist  
Republic of Sri Lanka as follows:—

1. This Act may be cited as the Local Authorities Filling of Vacancies (Special Provisions) (Amendment) Act, No. of 2014 and shall come into operation on such date as the Minister may appoint by Order published in the *Gazette*.
2. Section 2 of the Local Authorities Filling of Vacancies (Special Provisions) Act, No. 30 of 2013 is hereby amended by the repeal of the proviso to that section.
3. In the event of any inconsistency between the Sinhala and Tamil texts of this Act, Sinhala text shall prevail.
- Short title and date of operation.
- Amendment of section 2 of the Local Authorities Filling of Vacancies (Special Provisions) Act, No. 30 of 2013.
- Sinhala text to prevail in case of inconsistency.
