AN ACT TO INCORPORATE THE MARKAS SAKAFATHUL ISLAMIYYA

WHEREAS a Centre called and known as the “Markas Sakafathul Islamiyya” has heretofore been formed in Kal-Eliya for the purpose of effectually carrying out its objects and transacting all matters connected with the said Foundation according to the rules agreed to by its members: 5

Preamble.

AND WHEREAS the said Centre has heretofore successfully carried out and transacted several objects and matters for which it was established, and has applied to be incorporated, and it will be for the public advantage to grant the said application: 10

Be it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

1. This Act may be cited as the Markas Sakafathul Islamiyya (Incorporation) Act, No. 2015. Short title.
- 15 2. From and after the date of commencement of this Act, such and so many persons as now are members of the Markas Sakafathul Islamiyya (hereinafter referred to as the “Centre”) or shall hereafter be admitted as members of the Corporation hereby constituted, shall be a body corporate with perpetual succession under name and style of the “Markas Sakafathul Islamiyya” (hereinafter referred to as the “Corporation”) and by that name may sue and be sued, with full power and authority to have and use a common seal and alter the same at its pleasure. Incorporation of the Markas Sakafathul Islamiyya.
- 20 25 3. The general objects for which the Corporation is established are hereby declared to be— General objects of the Corporation.
  - (a) to establish and manage a centre for Islamic education, guidance and prayers;
