AN ACT TO INCORPORATE THE SUJEEWA SENASINGHE FOUNDATION

WHERE a Foundation called and known as the "Sujeewa Preamble. Senasinghe Foundation" has heretofore been establish in Sri Lanka for the purpose of effectually carrying out and transacting all objects and matters connected with the said 5 Foundation according to the rules agreed to by its members:

AND WHEREAS the said Foundation has heretofore successfully carried out and transacted the objects and matters for which it was formed and has applied to be incorporated and it will be for the public advantage to grant

BE it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:

1. This Act, may be cited as the Sujeewa Senasinghe Short title. Foundation (Incorporation) Act, No. of 2015.

From and after the date of commencement of this Incorporation Act, such and so many persons as now are members of the  $\frac{of the}{c_{1}$ "Sujeewa Senasinghe Foundation" (hereinafter referred to Senasinghe as the "Foundation") or shall hereafter be admitted as Foundation. members shall be a body corporate (hereinafter referred to as
- 20 the "Corporation") with perpetual succession under the name and style of "Sujeewa Senasinghe Foundation" and by that name may sue and be sued in all courts, with full power and authority to have and use a common seal and alter the same at its pleasure.

- 25 3. The general objects for which the Corporation is General constituted are hereby declared to be:--
  - objects of the Corporation.
  - (a) to give assistance and scholarships to needy children enable them to continue their education, encourage them to attend school regularly;

- (b) to give assistance and funds to public (Home) and private orphanages, for food programms;
- (c) to provide relief and welfare services in natural disasters, distress and unespected incidents;
- 5 (d) to give assistance and funds to public schools for constructions and repairs of buildings and training of teachers;
  - (e) to provide sports materials, consturct sports facilities and grant programms for the development of teaching sports skills of the youth;
  - (f) to created any activities (small industries or services) that can generate, on a non-profit base, the revenues to finance all actions in accordance to the above objects:
- 15 (g) to promote, arrange and organize events, festivals, artistic shows, publish newsletter or books to achieve these objects; and
  - (*h*) to liaise and co-ordinate with other local and foreign institutions or foundations which have similar objects.

4. (1) The affairs of the Corporation shall, subject Management to the other provisions of this Act and the rules in force for of the affairs the time being of the Corporation be administered by a of the Corporation. Board of Directors consisting of a Chairman, and Secretary,

25 Treasurer and eight other members elected in accordance with such rules.

(2) The Founder member of the Foundation Honourable Sujeewa Senasinghe shall be the Chairman of the Board of Directors for life. And thereafter the close family member of

30 the person who was holding office as the Chairman shall become the next Chairman of the Board of Directors.

(3) The first Board of the Corporation shall consist of the members of the Board of Administration of the Foundation holding office on the day immediately preceding the date of commencement of this Act.

Subject to the provisions of this Act and any other General written law, the Corporation shall have the power to do, powers of the perform and excute all such acts, matters and things whatsoever, as are necessary or desirable for the promotion or furtherance of the objects of the Corporation or any one
- 10 of them, including the power to acquire and hold property movable, to open, operate and close bank accounts, to borrow or raise moneys with or without security, to erect any building or structures on any land held by the Corporation and to engage, employ and dismiss officers and servants required
- 15 for the carrying out of the objects of the Corporation.

6. (1) It shall be lawful for the Corporation, from time Rules of the to time, at any General Meeting of the members and by a Corporation, majority of not less than two-thirds of the members present and voting, to make rules, not inconsistent with the

- 20 provisions of this Act or any other written law, for all or any of the following matters:-
  - (a) classification of membership, admission withdrawal, expulsion or resignation of members and membership fees payable;
- 25 procedure to be observed for the summoning and *(b)* holding of meetings of the Corporation and of the Board of Directors, the quorum for such meetings and the exercise and performance of their powers and duties;
- 30 (c) the appointment, power, duties and functions of the various officers, agents and servants of the Corporation;
  - (d) qulification required to become a member of the Corporation and of the Board of Directors; and

(e) the administration and management of the property of the Corporation.

(2) Any rules made by the Corporation may be amended, altered, added to or rescinded at a like meeting and in like 5 manner as a rule made under subsection (1).

(3) Every members of the Corporation shall be subject to the rules of the Corporation.

7. (1) The Corporation shall have its own fund and all Funds of the moneys hereafter to be received by way of gift, bequest, 10 donation, subscription, contribution, fees or grants for and on account of the corporation shall be diposited to the credit of the Corporation in one om more banks as the Board of

(2) There shall be paid out of the fund, all sums of money 15 required to defray any expenditure incurred by the Corporation in the exercise, performance and discharge of its power, duties and function under this Act.

8. The Coporation shall be able and capable in law to Corporation acquire and hold any property, movable and immovable may hold 20 which may become vested in it by virtue of any purchase, movable and grant, lease, gift, testamentary disposition, or otherwise and immovable. all such property shall be held by the Corporation for the purposes of this Act and subject to the rules in force for the time being of the Corporation, with full power to sell,

9. No member of the Corporation there remains after Limitation of the satisfaction of all its debts and liabilities of the Corporation or for any other purpose, be liable to make any contribution exceeding the amount of such membership fees

10. If upon the dissolution of the Corporation there Property remains after the satisfaction of all debts and liabilities any remaining on dissolution. property whatsoever, such property shall not be distributed among the members of the Corporation, but shall be given

- 11. (1) The Board of Directors of the Corporation shall Audit and 10 cause proper accounts to be kept of all moneys received and accounts of the expended by the Corporation.

(2) The financial year of the Corporation shall be the calendar year.

(3) The accounts of the Corporation shall be examined 15 and audited at least once in every year by an auditor or auditors appointed by the Board of Directors.

12. The Seal of the Corporation shall not be affixed to Seal of the any instrument whatsoever except in the presence of such Corporation. number of person as may be provided for in the rules in force

- 13. Nothing in this Act contained shall prejudice or Saving of the 25 affect the rights of the Republic or of any body politic, or Rights of the corporate or of any other persons except such as are Republic and others. mentioned in this Act and those claiming by, from or under them.
