AN ACT TO INCORPORATE THE RAVICHANDRA FOUNDATION

WHEREAS an Association called and known as the Preamble. "Ravichandra Foundation" has heretofore been formed in Colombo for the purpose of effectually carrying out and transacting the objects and matters connected with the said

5 Association according to the rules agreed to by its members:

AND WHEREAS the said Ravichandra Foundation has heretofore successfully carried out and transacted the several objects and matters for which it was established and has applied to be incorporated and it will be for the public 10 advantage to grant the said application:

BE it therefore enacted by the Parliament of the Democratic

Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the Ravichandra Foundation Short title. (Incorporation) Act, No. of 2015.

- 2. From and after the date of commencement of this Incorporation 15 Act, such and so many persons as now are members of the Ravichandra "Ravichandra Foundation" or shall hereafter be admitted as Foundation. members of the Corporation hereby constituted, shall be a body corporate with perpetual succession, under the name
- 20 and style of the "Ravichandra Foundation" (hereinafter referred to as "the Corporation") and by that name may sue, and be sued in all courts, with full power and authority to have and use a common seal and alter the same at its pleasure.

3. The general objects for which the Corporation is General objects of the 25 constituted are hereby declared to be-Corporation.

- (a) to assist the relevant authorities in promoting and nurturing our national heritage and unique cultures;

- (b) to assist the relevant authorities that promote creation and protection of innovative products by furthering 3.(a) above and in generating of self employment;
- 5 (c) to assist the relevant authorities to create business opportunities to market products that protect and promote our culture, secure a reasonable price for their products and protect their professions;
- (d) to assist the relevant authorities to protect national
  arts and culture for posterity and creating business opportunities for the sale of such products;
  - (e) to promote economic development by assisting the relevant authorities to implement agricultural projects such as promotion of usage of organic fertilizer;
  - (*f*) to assist the relevant authorities in providing relief to those affected by natural disasters;
  - (g) to assist the relevant authorities in the private, public and NGO sector to uplift educational, health and economic standards of the underprivileged persons in the nation;
  - (*h*) to assist the relevant authorities to provide financial and other assistance to underprivileged students;
  - (i) to assist the relevant authorities to establish and or maintain vocational/technical educational institutes for underprivileged students and assist them to complete the courses;
    - (j) to assist the relevant authorities to establish and maintain organizations that foster love and provide protection and covering to handicapped and destitute children;

- (k) to assist the relevant authorities that promote a clean environment for a healthy lifestyle;
- (l) to assist the relevant authorities to promote sustainable development in the country by providing assistance and opportunities to the under privileged and unemployed persons secure employment and uplift their standards of living;
- (m) to assist the relevant authorities to organize free medical camps and clinics and distribution of free medicine to the needy and underprivileged persons;
- *(n)* to assist the relevant authorities which collaborate with foreign parties and organizations for the provisions of assistance for underprivileged persons of Sri Lanka;
- (o) to promote, arrange and organize exhibitions, 15 lectures, discussions, workshops, panel discussion and other similar activities and to print, publish and distribute books, journals, bulletins etc. with a view to promoting the objectives of the Corporatoin; and
- 20 to do all such other acts as may be necessary for the (p)carrying out of all or any of the aforesaid objects.

4. Subject to the provisions of this Act and any other General written law the Corporation shall have the power to do, powers of the perform and execute all such acts, matters and things 25 whatsoever, as are necessary or desirable for the promotion or furtherance of the objects of the Corporation or any one of them, including the power to acquire and hold property movable or immovable, to open, operate and close bank accounts to borrow or raise money with or without security

30 to receive or collect grants, donations, to invest its funds, to erect any building or structures on any land held by the Corporation and to engage employ dismiss officers and servants required for the carrying out of the objects of the Corporation.

5. (1) The affairs of the Corporation shall, subject to Management other provisions of this Act and the rules in force for the time of the affairs being of the Corporation, be administered by a Board of Corporation. Directors (hereinafter referred to as the "Board") consisting 5 of a Chairman, Vice Chairman, Managing Director, Secretary

and Treasurer and a maximum of seven other Directors elected in accordance with the rules of the Corporation.

(2) The first Board of Directors of the Corporation shall consist of the members of the Board of the Association 10 holding office on the day immediately preceding the date of commencement of this Act. Such Board shall hold office until a Board of Directors is elected in accordance with the rules of the Corporation.

6. (1) It shall be lawful for the Corporation from time Rules of the 15 to time, at any general meeting and by a majority of votes of Corporation. not less than two-thirds of the members present, to make rules not inconsistent with the provisions of this Act, or any other written law, for all or any of the following matters and any matter in relation to the management of the affairs of the 20 Corporation and accomplishment of its objects:-

- (a) the classification of members and membership fees, their admission, withdrawal, or expulsion from membership;
- (b) the election of the members to the Board of Directors and their powers and duties;
- (c) the election of office bearers, their term of office, resignation from, vacation of or removal from office and their powers and duties;
- (d) the procedure to be followed in the summoning and holding of meetings of the Council, the quorum therefore and the conduct of business thereat:

(e) the administration and management of the property of the Corporation, including funds;

(2) Any rule made by the Corporation may be altered, added to, amended or rescinded at a like meeting and in like 5 manner as a rule made under subsection (1).

(3) The members of the Corporation shall be subject to rules of the Corporation.

7. (1) The Corporation shall have its own fund and all Funds of the Corporation. moneys heretofore or hereafter to be received by way of gifts,

10 bequests, donations, subscription, testamentary dispositions, fees, grants for donations or contributions in cash or kind from local or foreign institutions and individuals, members and non-members.

(2) All monies received shall be deposited in the name of 15 the Corporation in one or more banks and be invested in any suitable manner as the Board shall determine.

(3) All expenditure incurred by the Corporation in the exercise, performances and dischage of its powers, duties and functions of the Corporation shall be paid out of the

20 Funds of the Corporation.

8. All debts and liabilities of the Association existing Debts due by on the day preceding the date of commencement of this Act, and payable shall be paid by the Corporation hereby constituted and all debts due to subscription and contribution payable to the

25 Association on that day shall be paid to the Corporation for the purpose of this Act.

9. No member of the Corporation shall for the purpose Limitation of discharging the debts and liabilities of the Corporation liabilities of or for any other purpose be liable to make any contribution members. 30 exceeding the amount due from such member as

10. The Corporation shall be able and capable in law to Corporation acquire and hold any property, movable or immovable which  $^{\rm may\ hold}$ may become vested in it by virtue of any purchase, grant, property movable and gift, testamentary disposition, trust or otherwise and all such immovable. 5 property shall be held by the Corporation for the purpose of this Act, and subject to the rules in force for the time being of the Corporation, with full power to sell, mortgage, lease, exchange or otherwise dispose of the same, and in the case of a trust, the Corporation shall deal with it in the manner 10 provided for by the trust.

11. The Seal of the Corporation shall not be fixed to Seal of the any instrument whatsoever, except in the presence of such Corporation. number of persons as may be provided for in the rules in force for the time being of the Corporation, who shall sign

15 their names to the instrument in token of their presence, and such signing shall be independent of the signing of any person as witness.

12. Nothing in this Act contained shall prejudice or Saving of the affect the rights of the Republic or of any body politic or rights of the Republic and

20 corporate, or of any other persons, except such as mentioned others. in this Act and those claiming by, from or under them.

13. In the event of any inconsistency between the Sinhala text Sinhala and the Tamil texts of this Act, the Sinhala text shall to prevail in case of prevail. inconsistency.
