AN ACT TO INCORPORATE THE THIDORA-THEATRE INSTITUTE FOR DISABILITY ORIENTED RESEARCH AND ADVOCACY

WHEREAS an Association called and known as the Preamble. "Thidora-Theatre Institute for Disability Oriented Research and Advocacy" has been formed for the purpose of effectually carrying out and transacting all objects and matters connected 5 with the said Association according to the rules agreed to by its members:

AND WHEREAS the said Association has heretofore successfully carried out and transacted the several objects and matters for which it was formed and has applied to be 10 incorporated, and it will be for the public advantage to grant such application:

BE it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the Thidora-Theatre Short title. 15 Institute for Disability Oriented Research and Advocacy (Incorporation) Act, No. of 2015.

2. From and after the date of commencement of this Incorporation Act, such and so many persons as are now members of the of the "Thidora-Theatre Institute for Disability Oriented Research Theatre 20 and Advocacy" (hereinafter referred to as "the Institution") Institute for and such other persons as shall hereinafter be admitted Oriented as members of the Corporation hereby constituted shall Research and be a body corporate with perpetual succession, under the Advocacy. name and style of "Thidora-Theatre Institute for 25 Disability Oriented Research and Advocacy" (hereinafter referred to as "the Corporation") and by that name may sue and be sued in all courts, with full power and authority to

- 3. The general objects for which the Corporation is General constituted are hereby declared to be-

objects of the Corporation.

(a) to promote and enhance the creativity of the disabled and disadvantaged in Sri Lanka and to facilitate their integration into the Sri Lankan society;

- (b) to promote the self respect for the disabled and desadvantage amongst the Sri Lankan society;
- (c) to act against discriminations against the disabled 10 and disadvantaged in Sri Lanka and to intervene in drafting and implementing laws for their protection; and
- (d) to collaborate with other organizations having similar objectives to those of the Corporation 15 whether in Sri Lanka or abroad.
 - 4. (1) The management, control and administration of the Management affairs of the Corporation shall, subject to the provisions of this Act and of the rules of the Corporation, administered by a Board of Management consisting of such number of office bearers as may be provided for in such rules and elected in accordance therewith.

- (2) The founder member of the Institution Mr. Rohana Deva Perera shall be the Chairman of the Board of Directors for life.
- 25 5. Subject to the provisions of this Act, and any other General written law, the Corporation shall have the power to do, perform and execute all such acts, matters and things whatsoever as are necessary or desirable for the furtherance of the objects of the Corporation or any one of them, and subject to the rules of Corporation, to open, operate and close bank accounts, to borrow or raise money with or without security, to receive or collect grants and donations, to invest

its funds and to engage, employ and dismiss, officers and servants are required for the purpose of achieving the objects of the Corporation.

6. (1) The financial year of the Corporation shall be Audit of 5 01st April to 31st March.

- (2) The Corporation shall cause proper accounts to be kept of all income and expenditure, assets and liabilities and all other transactions of the Corporation.
- (3) The accounts of the Corporation shall be audited annually by a qualified auditor appointed by the Corporation.
 - (4) In this section "qualified auditor" means—

- (i) an individual who being a member of the Institute of Chartered Accountant of Sri Lanka or any other institute established by law, possesses a certificate to practice as an accountant issued by the Council of such Institute; or
- (ii) a firm of Accountants each of the resident partners of which, being a member of the Institute of Chartered Accountant of Sri Lanka or of any other institute established by law, possesses a certificate to practice as an accountant issued by the Council of such Institute.
- 7. (1) It shall be lawful for the Corporation from time to time at any general meeting of the Corporation and by the votes of not less than two-thirds of the members present and voting, to make rules, not inconsistent with the provisions of this Act or any other written law, for the admission, withdrawal or expulsion of members, the election of the office-bearers for the conduct of the duties of the office-bearers, agents,
 30 officers and servants of the Corporation, for the procedure to be followed in the transaction of business by the Corporation

and the Board of Management and generally, for the management of the affairs of the Corporation and the accomplishment of its objects. Such rules when made may at a like meeting and in like manner, be altered, added to, amended or rescinded.

- (2) All members of the Corporation shall be subject to the rules of the Corporation.
- 8. The money and property of the Corporation however Application derived shall be applied solely towards the promotion of the 10 objectives as set forth herein and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, loan, bonus, or otherwise, by way of profit to the members of the Corporation.

9. The Corporation shall be able and capable in law, to Corporation 15 acquire and hold any property movable or immovable, which may become vested in it by virtue of any purchase, grant, gift, testamentary disposition or otherwise, and all such property shall be held by the Corporation for the purposes of this Act, and subject to the rules in force for the time being of the Corporation, with full power to sell, mortgage, lease, exchange or otherwise dispose of the same.

10. All debts and liabilities of the Institution existing Debts due on the day preceding the date of commencement of this Act, shall be paid by the Corporation, and all debts due to 25 subscriptions, fees and contributions payable to the Association on that day, shall be paid to the Corporation for the purposes of this Act.

11. The seal of the Corporation shall be in the custody of Seal of the the Corporation and it shall not be affixed to any instrument whatsoever, except in the presence of the Chairman and one of the two Directors appointed by the Board of Management who shall sign their names to the instrument in token of their presence and such signing shall be independent of the signing of any person as a witness.

If upon the winding up or the dissolution of the Property Corporation there remains after the satisfaction of all its debts and liabilities, any property whatsoever, such property shall not be distributed among the members of the of the Corporation, but shall be given or transferred to some other Corporation. institution or institutions having objects similar to those of the Corporation and which is or are by its or their prohibited from distributing any income or property among its or their members.

- 10 13. Nothing in this Act contained shall prejudice or Saving of affect the rights of the Republic or of any body politic or the rights of corporate.
- 14. In the event of any inconsistency between the Sinhala text Sinhala and Tamil texts of this Act, the Sinhala text shall 15 prevail.
