STATEMENT OF LEGAL EFFECT

Clause 2: This clause amends section 135 of the Code of Criminal Procedure Act, No. 15 of 1979 (hereinafter referred to as the "principal enactment") by including section 291c of the Penal Code in paragraph (*e*) of subsection (1) thereof, and the legal effect of the section as amended is to make the Attorney General's sanction a pre-requisite to take cognizance of an offence punishable under section 291c.

Clause 3: This clause amends the First Schedule to the principal enactment and makes an amendment consequential to the amendment made by clause 2.

BE it enacted by the Parliament of the Democratic Socialist

1. This Act may be cited as the Code of Criminal Short title. Procedure (Amendment) Act, No. of 2015.

- 10 section 291B of the Penal Code", of the words and figures "any offence punishable under section 290A, 291B or 291C of the Penal Code".

3. The First Schedule to the principal enactment is hereby Amendment amended by the insertion immediately after the entries relating of the First 15 to section 291B of the following new entries:—
