AN ACT TO INCORPORATE THE SOUTH LANKA ACADEMY FOR TERTIARY EDUCATION AND LEADERSHIP.

WHEREAS an Academy called and known as the Preamble. "South Lanka Academy for Tertiary Education and Leadership" has heretofore been created for the purpose of effectually carrying out and transacting all objects and

5 matters connected with the said Academy according to the rules agreed to by its members:

AND WHEREAS the said Academy has heretofore successfully carried out and transacted the several objects and matters for which it was established and has applied to

10 be incorporated and it will be for the public advantage to grant the application:

BE it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the South Lanka Academy Short title. 15 for Tertiary Education and Leadership (Incorporation) Act, No. of 2015.

2. From and after the date of commencement of this Incorporate Act, such and so many persons as now are members of the the South "South Lanka Academy for Tertiary Education and Academy for

- 20 Leadership" (hereinafter referred to as "the Academy") or Tertiary shall hereafter be admitted as members of the Corporation and hereby constituted, shall be a body corporate with perpetual Leadership. succession under the name and style of the "South Lanka Academy for Tertiary Education and Leadership" (herein
- 25 after referred to as "the Corporation") and by that name may sue and be sued and shall have full power and authority to have and use a common seal and to alter the same at its pleasure.

3. The general objects for which the Corporation is General objects of the constituted are hereby declared to be to—

- (*a*) to assist students who prepare for government examinations by conducting lectures, seminars and study tours;
- (b) to conduct academic lectures, seminars, exhibitions related to intellectual development of people executive action guidance and to organize relevant exhibitions, educational and propaganda activities;
- 10 (c) to establish library facilities and conduct training programs of all types in the field of mass communication (television, radio, internet, newspapers and publications) and maintain such units;
- 15 (d) to assist needy students by providing them with books and other equipment and school uniforms and to grant scholarships to students who are in the secondary and tertiary stage of their education;
- (e) to identify the inherent talents of students and youth
 at rural, district and provincial levels in areas such as sports, literature and art and to encourage them to excel in them by providing the required infrastructure;
- (f) to identify projects suitable for young school
 leavers and assist them by carrying out such projects with a view to training such youth to meet the competitive demands for future employment;
 - (g) to assist those in need of financial and other forms of assistance to enhance their inborn talents and skills enabling them to engage in self-employment;

- (h) to extend all forms of assistance to the differently- abled in developing their personality and to implement all types of support programs relevant to preschool/ early childhood education;
- 5 (*i*) to identify the health requirements of the people in rural and remote areas and to conduct medical camps and clinics in such areas and to supply medicines to the needy through such camps and clinics;
- 10 (*j*) to conduct awareness programmes for youth in order to promote a tobacco, alcohol and a drug free society and build a healthy, disciplined, patriotic and human generation;
- (k) to take active measures for the preservation ofenvironment and balanced development;
 - (*l*) to encourage the farmers, fishermen and establish young farmers, and fishermen's organizations;
 - (*m*) to utilize the labour of youth and adults for the welfare of the general public and during emergencies and national disasters;
 - (n) to foster and promote mutual understanding, a spirit of national consciousness, goodwill and friendship among the citizens of Sri Lanka and to promote peace and harmony among the Sinhala, Tamil, Muslim and Burgher communities in Sri Lanka;
 - (*o*) to promote religious harmony, mutual understanding, peaceful co-existence, spiritual development and friendship among the people of Sri Lanka through religious, cultural, social and economic interactions;

- (p) to conduct programmes to discuss the problems faced by the youth in different areas in Sri Lanka due to lack of infrastructure facilities such as electricity, water, housing and roads and provide amnesties to such needy people;
- (q) to organize and mobilize people to deploy them in voluntary activities in order to find solutions to shortcomings in infrastructure;
- (r) to facilitate the exchange of delegations with other
 international organizations having similar objects
 with a view to building friendship and
 understanding between Sri Lanka and other
 countries;
- (s) to assemble and mobilize all groups under this
 Academy with a view to promoting national harmony and peace within Sri Lanka; and
 - (*t*) to do all such other acts, matters and things as are incidental or conductive to the attainment of the objectives of the corporation.
- 20 **4.** Subject to the provisions of this Act and any other Powers of the written law, the Corporation shall have the power to—
 - (*a*) open, operate and close bank accounts;
 - (b) borrow or raise money with or without security and to receive or collect grants and donations;
- 25 (c) invest any funds of the Corporation which are not immediately required for the purpose of the Corporation in a way that may be determined by the Committee of Management;
- (d) purchase, acquire, give on lease or hire, sell or30 otherwise obtain any movable or immovable

property which may be required for the purpose of the Corporation and which may lawfully be acquired for those purposes and to deal with or dispose of the same, as it may deem expedient with a view to promoting the objects of the Corporation;

- (e) appoint, employ and dismiss the employees required for the carrying out of the objects of the Corporation and pay them such remuneration as may be determined by the Corporation;
- 10 (f) enter into, perform or carry out, whether directly or through any officer or agent authorized in that behalf of the Corporation, all such contracts or agreements as may be necessary for the attainment of the objects of the exercise of the powers of the 15 Corporation;
 - (g) appoint, advisory councils, committees or sub committees as and when necessary to carry out any functions of the Corporation as may be determined by the Committee Management.
- 20 5. (1) The management of the affairs of the Corporation Management shall be subject to the rules of the Corporation, be done by a $\frac{1}{2}$ of the affairs Committee of Management consisting of not more than six Corporation. office bearers inclusive of the Chirman / Managing Director, Sectary, Trasura and such number of members as may be

25 provided or in rules and elected in accordance therewith.

(2) No act or proceeding of the Committee of Management shall be deemed to be invalid by reason only of the existence of a vacancy among its members or any defect on the election or nomination of a member thereof.

30 (3) The first Committee of Management shall consist of the members of the Committee of Management holding office

on the day immediately preceding the date of commencement of this Act and shall continue to hold office until a new Committee of Management is elected in accordance with the rules made under section 6 of this Act.

- 5 6. (1) It shall be lawful for the Corporation, from time to Rules of the time, at any general meeting and by a majority of not less than two-thirds of the members present to make rules not inconsistent with the provisions of this Act, or any other written law, on all or any of the following matters:-
- 10 (a) the classification of members and the admission, resignation or expulsion of members;
 - (b) the election of the office-bearers, the resignation from, vacation of or removal from office of officebearers, and their powers, conduct and duties;
- 15 (c) the election of the members of the Committee of Management and its powers, duties and conduct and the terms of office of members of the Committee of Management;
- (d) the powers, duties, functions and conduct of the 20 officers, agents and servants of the Corporation;
 - (e) the procedure to be observed at and the summoning and holding of meetings of the Committee of Management, the times, places, notices and agenda of such meetings, the quorum thereof and the conduct of business thereat:
 - (f) the administration and management of the property of the Corporation the custody of its funds, and the maintenance and audit of its accounts; and
 - (g) the management of the affairs of the Corporation, and the accomplishment of its objects.

(2) Any rule made by the Corporation may be amended, altered, added or rescinded at a like meeting and in the like manner, as a rule made under subsection (1).

(3) The members of the Corporation shall be subject to 5 the rules of the Corporation.

8. Subject to the provisions of this Act, the Corporation Corporation 10 shall be able and capable in law to acquire and hold any property both movable and immovable, which may become immovable vested in it by virtue of any purchase, grant, gift, testamentary property. disposition or otherwise, and all such property shall be held by the Corporation for the purpose of this Act and subject to

15 the rules of the Corporation made under section 6, with full power to sell, mortgage, lease, exchange or otherwise dispose of the same.

9. (1) The Corporation shall have its own fund and all Fund of the monies heretofore or hereafter to be received by way of gifts, 20 testamentary dispositions, grants, donations or contributions or fees on behalf of the Corporation shall be deposited to the credit of the Fund of the Corporation in one or more banks

(2) The Corporation may establish a depreciation fund or 25 a sinking fund for the purpose of rehabilitation, development or improvement of the property of the Corporation.

(3) There shall be paid out of the Fund all sums of money to defray any expenditure incurred by the Corporation in the exercise, performance and discharge of its powers, duties 30 and functions under this Act.

(4) The financial year of the Corporation shall be the calendar year.

All debts and liabilities of the Academy existing on Debts due by the day proceeding the date of commencement of this Act, and payable to the shall be paid and discharged by the Corporation hereby Academy. constituted and all debts due to, subscriptions and 5 contributions payable to the Academy on that day shall be paid to the Corporation for the purpose of this Act. 11. No member of the Corporation shall for the purpose Limitation of of discharging the debts and liabilities of the Corporation or liabilities of for any other purpose, be liable to make any contribution members. 10 exceeding the amount due from such member as membership fees. 12. (1) The Corporation shall caust proper accounts to Accounts and be kept of its income and expenditure, assets and liabilities Audit. and all other transactions of the Corporation. (2) The accounts of the Corporation shall be audited by 15 a qualified auditor. (3) In this section, "qualified auditor" means — (a) an individual who being a member of the institute of Chartered Accountants of Sri Lanka, or of any 20 other Institute established by law, possesses a certificate to practice as an Accountant issued by the Council of such Institute; or (b) a firm of Accountants each of the resident partners of which, being a member of the institute of 25 Chartered Accountants of Sri Lanka or of any other institute established by law, possesses a certificate of practice as an Accountant issued by the Council of such Institute.

13. The seal of the Corporation shall not be affixed to Seal of the 30 any instrument whatsoever, except in the presence of the Corporation. Chairman/Managing Director and the Secretary or two other members of the Corporation as may be decided by the

Committee of Management who shall sign their names to the instrument in token of their presence and such signing shall be independent of the signing of any person as a witness.

5 14. If upon the dissolution of the Corporation, there Property remains any property whatsoever, after the satisfaction of all remaining on dissolution debts and liabilities, such property shall not be distributed among the members of the Corporation, but shall be given or transferred to some other institution or institutions having

10 objects similar to those of the Corporation, and which is or are by its rules prohibited from distributing any income or property among its or their members. Such institution or institutions may be determined by the members of the

Committee of Management on or before the dissolution of

15 the Corporation.

15. Nothing contained in this Act shall prejudice affect Savings of the rights of the Republic or any body politic or corporate. the rights of

the Republic and others.

16. In the event of any inconsistency between the Sinhala text Sinhala and Tamil texts of this Act, the Sinhala text shall to prevail in 20 prevail.
