AN ACT TO INCORPORATE THE SRI LANKA HIRA FOUNDATION

WHEREAS an Association called and known as the Preamble. "Sri Lanka Hira Foundation" has heretofore been formed 10/18, Lake Drive, Colombo-08 the purpose of effectually carrying out and transacting all objects and matters

5 connected with the said Foundation according to the rules agreed to by its members:

AND WHEREAS the said Association has heretofore successfully carried out and transacted the several objects and matters for which it was formed and has applied to be

10 incorporated and it will be for the public advantage to grant such application.

BE it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the "Sri Lanka Hira Short title. 15 Foundation" (Incorporation) Act, No. of 2015.

2. From and after the commencement of this Act, such Incorporation and so many persons as now are members of the "Sri Lanka $^{\rm of \ the}_{\rm Sri \ Lanka}$ Hira Foundation" (hereinafter referred to as the "Foundation") Hira or shall hereafter be admitted as members of the Corporation Foundation.

- ²⁰ hereby constituted shall be a body corporate (hereinafter referred to as the "Corporation") with perpetual succession, under the name and style of the "Sri Lanka Foundation" and by that name may sue and be sued in all courts, with full power and authority to have and use a common seal and 25 alter the same at its pleasure.

3. The general objects for which the Corporation is General constituted are hereby declared to be-

objects of the Corporation.

(a) Working to protect and develop all rights of women and children:

- (b) assist affected people in disaster situation to uplift their life-style and providing legal assistance for needy vulnerable people;
- (c) protect cultural values;
- 5 (*d*) giving assistance to develop worship places;
 - (e) to promote peace, goodwill, understanding and cooperation among all communities and people of Sri Lanka;
- (f) to give assistance, prizes and scholarships to needy
 school children to enable to continue their education, encourage them to attend school regularly, and assist them in their education;
 - (g) to establish self-employment opportunities for unemployed citizens and to provide loans and to inaugurate various savings schemes;
 - (h) to take necessary steps to promote artistic creations, sport skills and technical knowledge of school leavers and to set up vocational training centers as well as give them assistance to peruse studies in computer science and technology and to establish institutions to provide such studies;
 - (i) to assist in the development of educational, religious, cultural, aesthetic and sports facilities without any reference to race, religion or caste and to conduct various festivals and competitions;
 - (*j*) to provide medical relief and food for the poor, destitute and sick persons, establish and maintain houses to maintain Children homes and day care centers for children and elders;
- 30 (*k*) to liaise and co-ordinate with other local or foreign institutions which have similar objects.

4. (1) The affairs of the Corporation shall, subject to Management the other provisions of this Act and the rules in force for the of the affairs of the time being of the Corporation be administered by a Board Corporation. of Directors consisting of Chairman, Secretary General,

5 Director Finance, Chairman, Administrative Director and other six members elected in accordance with such rules.

(2) The founder member of the Foundation, Honourable Minister, M. L. A. Hizbullah shall be the Chairman of the Board of Directors for life and thereafter, the Family members

¹⁰ of the person who was holding office as the Chairman shall become the next Chairman of the Board of Directors.

(3) The first Board of the Corporation shall consist of the members of the Board of Administration of the Foundation holding office on the day immediately preceding the date of 15 commencement of this Act.

(4) A member of the Board of Directors other than the Chairman shall unless he vacates his office earlier by death or resignation, hold office for a period of four years. Where due to death or resignation a vacancy occurs in the Board of

20 Directors a new members shall be appointed to fill such Vacancy and such a new members shall hold office for a period of four years.

5. Subject to the provisions of this Act and any other Genral written law, the Corporation shall have the power to do, Powers of the Corporation. 25 perform and execute all such acts matters and things whatsoever as are necessary or desirable for the promotion or furtherance of the objects of the Corporation or any one of them, including the power to acquire and hold property movable, to open, operate and close bank accounts, to borrow

30 or raise moneys with or without security, to erect any building or structures on any land held by the Corporation and to engage, employ and dismiss officers and servants required for the carrying out of the objects of the Corporation.

6. (1) It shall be lawful for the Corporation from time to Rules of the time, at any general meeting of the members and by a majority Corporation. of not less than two-thirds of the members present and voting, to make rules, not inconsistant with the provisions

5 of this Act or any other written law, for all or any of the following matters:-

- (a) classification of membership, admission, withdrawal, expulsion or resignation of membership fees payable;
- 10 (b) procedure to be observed for the summoning and holding of meetings of the Corporation and of the Board of Directors, the quorum for such meetings and the exercise and performance of their powers and duties;
- 15 (c) the appointment, power, duties and functions of the various officers, agents and servants of the Corporation;
 - (d) qualification required to become a member of the Corporation and of the Board of Directors; and
- 20 (e) administration and management of the property of the Corporation.

(2) Any rule made by the Corporation may be amended, altered, added to or rescinded at a like meeting and in like manner as a rule made under subsection (1).

25 (3) Every member of the Corporation shall be subject to the rules of the Corporation.

7. All debts and liabilities of the Foundation existing Debts due by on the day preceding the date of commencement of this Act, and payable shall be paid by the Corporation hereby constituted and all Foundation.

30 debts due to subscriptions and contributions payable to the Foundation on that day shall be paid to the Corporation for purposes of this Act.

8. (1) The Corporation shall have its own fund and all Fund of the Corporation. moneys heretofore or hereafter to be received by way of gifts, bequest, donation, subscription, contribution, fees or grants for and on account of the Corporation shall be

5 deposited to the credit of the Corporation in one or more banks as the Board of Directors shall determine.

(2) There shall be paid out of the fund, all sums of money required to defray any expenditure incurred by the Corporation in the exercise performance and discharge of

10 its power, duties and functions under this Act.

9. The Corporation shall be able and capable in law Corporation to acquire and hold any property, movable and immovable may hold which may become vested in it by virtue of any purchase, movable and grant, lease, gift, testamentary disposition or otherwise, immovable.

- 15 and all such property shall be held by the Corporation for the purposes of this Act and subject to the rules in force for the time being of the Corporation, with full power to sell, mortgage, lease, exchange or otherwise dispose of the same.

12. (1) The Board of Directors of the Corporation shall Audit and cause proper account to be kept of all moneys received and the expended by the Corporation. Corporation.

(2) The financial year of the Corporation shall be the 5 calendar year.

(3) The Accounts of the Corporation shall be examined and audited at least once in every year by an auditor and auditors appointed by the Board of Directors.

13. The seal of the Corporation shall not be affixed to Seal of the Corporation. 10 any instrument whatsoever except in the presence of such number of person as may be provided for in the rules in force for the time being of the Corporation, who shall sign their names to the instrument in token of their presence and such signing shall be independent of the signing of any person 15 as a witness.
