STATEMENT OF LEGAL EFFECT

Clause 2: This clause amends section 2 of the Value Added Tax Act, No. 14 of 2002 (hereinafter referred to as the "principal enactment"), and the legal effect of the section as amended is to introduce the reduction of the rate to 11% and to restrict the deferment by a Strategic Development Project under SVAT only during the project implementation period.

Clause 3 : This clause amends section 3 of the principal enactment and the legal effect of the section is to extend the liability on wholesale and retail trade where the total turnover for a period of 3 months exceeds Rs.100 million.

Clause 4 : This clause amends section 5 of the principal enactment to provide for the removal of the condition referred to in the consideration on termination of the lease.

Clause 5 : This clause amends section 7 of the principal enactment to extend the registration of buying office under SVAT Scheme.

Clause 6 : This clause amends section 8 of the principal enactment in order to remove the deemed tax liability on locally produced fresh milk.

Clause 7 : This clause amends section 10 of the principal enactment and the legal effect of the section as amended is to extend the liable threshold for registration.

Clause 8 : This clause amends section 16 of the principal enactment to provide for the publication in the official website of the Inland Revenue, the inactive files which may be updated on monthly basis.

Clause 9: This clause amends section 17 of the principal enactment which is consequential to the amendment made by clause 16 of the Act.

 $Clause \ 10$: This clause amends section 19 of the principal enactment which is consequential to the amendment made by clause 16 of the Act.

Clause 11: This clause amends section 21of the principal enactment which is consequential to the amendment made by clause 16 of the Act.

Clause 12: This clause amends section 22 of the principal enactment and the legal effect of the section is to provide for the issue of guidelines by the Commissioner-General for the application of financial consolidation process.

 $Clause \ 13$: This clause amends sections 25Aof the principal enactment and is consequential to the amendments made by the registration threshold.

Clause 14 : This clause amends sections 25C of the principal enactment and is consequential to the amendment made to reduce the rate to 11%.

Clause 15: This clause amends section 25F of the principal enactment and the legal effect of the section as amended is to bring the leasing transactions liable to VAT on financial services.

Clause 16: This clause inserts a new section to provide for the use of electronic communication or electronic records.

Clause 17,18, 19,20, 21,22 and 23: These clauses amend sections 26, 28, 34,41,44,47 and 66 of the principal enactment and is consequential to the amendment made by clause 16 of this Act.

Clause 24 : This clause amends section 83 of the principal enactment to substitute the definition of the expression "taxable period".

Clause 25 : This clause amends Schedule I of the principal enactment to introduce certain exemptions to PART II of that Schedule.

Clause 26: This clause amends the amendment made to the principal enactment by section 13 of the Amendment Act No 7 of 2014, for better clarification.

AN ACT TO AMEND THE VALUE ADDED TAX ACT, NO. 14 OF 2002

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. (1) This Act may be cited as the Value Added Tax Short title (Amendment) Act, No. of 2015 and subject to subsection and the date of operation. 5 (2) of this section, shall be deemed to have come into operation on January 1, 2015 unless the date on which certain provisions shall come into operation are specified in such sections.

(2) The amendments made to section 17, 19, 21, 25A(5),10 26, 28, 34, 41, 44, 47 and 66 by this Act shall come into operation on such date as the Minister may appoint by Order published in the Gazette.
