STATEMENT OF LEGAL EFFECT

Clause 2 : This clause amends the Fisheries (Regulation of Foreign Fishing Boats) Act (hereinafter referred to as the “principal enactment”) by making a general amendment and the legal effect of the section as amended is to transfer the functions of the Secretary in relation to the subject to the Director General.

Clause 3 : This clause amends section 3 of the principal enactment and the legal effect of the section as amended is to include Director General of Coast Guard Department and any other person designated by name or by office by the Minister in writing as persons who are authorized to implement and enforce the provisions of the Act.

Clause 4 : This clause amends section 13 of the principal enactment and the legal effect of the section as amended is–

- (1) to enable any authorized officer to–
 - (i) bring any abandoned foreign fishing boat to the nearest port;
 - (ii) produce any foreign fishing boats seized or detained as the case may be under this Act with the crew where such boat is not abandoned, before the Magistrate instead of High-Court in order to overcome practical difficulties; and
- (2) to transfer the authority of the Director or the Government agent to the Director General.

Clause 5 : This clause amends section 13 of the principal enactment by introducing new section 13A and the legal effect of the section as amended is to provide for the submission of a notice to the consular officer of the country to which the abandoned or seized foreign fishing boat belongs with details specified therein and for recovery of cost and incidental expenses accrued, to the Government of Sri Lanka in respect of the detention.

Clause 6 : This clause amends section 15 of the principal enactment and the legal effect of the section as amended is to impose enhanced fines based on the length of the fishing boat for the offences committed contravening section 4 and section 5 of the Act in the territorial waters and the Exclusive Economic Zone of Sri Lanka.

Clause 7 : This clause amends section 16 of the principal enactment and the legal effect of the section as amended is to enable the Magistrates to exercise power in respect of offences committed under this Act, and to enhance the fine in respect of violation of conditions of a permit by a foreign fishing boat.

Clause 8 : This clause amends section 17 of the principal enactment and the legal effect of the section as amended is to enable Magistrates to exercise power in respect of enhanced fines for the offence of obstructing authorized officers, taking into consideration the length of the fishing boat.

Clause 9 : This clause inserts new section 17A to the principal enactment and the legal effect of the section as amended is to make all offences committed under this Act cognizable and non-bailable.

Clause 10 : This clause amends section 18 of the principal enactment and is consequential to the amendment made by clause 8.

Clause 11 : This clause amends section 19 of the principal enactment and the legal effect of the section as amended is to enable High Court to hear the original appeals giving an opportunity to be heard again by Court of Appeal and to change the designation of Director as the Director General.

Clause 12 : This clause inserts new sections 19A, 19B and 19C to the principal enactment and the legal effect of the section as amended is to vest the ownership of the abandoned foreign fishing boat in the State until legal entitlement is proved by a relevant party within the prescribed period to the Magistrate.

Clause 13 : This clause amends section 20 of the principal enactment and the legal effect of the section as amended is to provide for the imposition of a penalty by the Director General for offences committed for the first time in the Exclusive Economic Zone together with procedure to be adhered to.

Clause 14 : This clause amends section 20 of the principal enactment by the insertion of new section 20A to the principal enactment and the legal effect of the section as amended is to provide for the appointment of a panel of experts.

Clause 15 : This clause amends section 21 of the principal enactment and the legal effect of the section as amended is to provide for the release of any boat on the provision of a satisfactory bond or security until the conclusion of any prosecution and to enable the Magistrate to exercise powers in respect of offences committed under this Act.

Clause 16 : This clause amends section 23 of the principal enactment and the legal effect of the section as amended is to make provision for the presumption, on violation of the provisions of the Act where a foreign fishing boat is found in Sri Lanka Waters.

Clause 17 : This clause amends section 24 of the principal enactment and the legal effect of the section as amended is to enable the Magistrate to exercise powers in respect of offences committed under this Act.

Clause 18 : This clause amends section 26 of the principal enactment and the legal effect of the section as amended is to widen the regulation making power for the implementation of standards stipulated in International conventions and agreements.

Clause 19 : This clause amends section 26 of the principal enactment by the insertion of new section 26A and the legal effect of the section as amended is to impose a fine in respect of violation of regulations.

Clause 20 : This clause amends section 27 of the principal enactment by the insertion of new section 27A and the legal effect of that section as amended is to establish a fund called and known as Fisheries Reward Fund.

Clause 21 : This clause amends section 28 of the principal enactment and the legal effect of the section as amended is to include new definitions to the expressions “abandoned foreign fishing boat” and “Director General” and to substitute definitions for the expressions “fish”, “fishing”, “local fishing boat”, “related activities”, “Secretary” and “Sri Lanka Waters”.

AN ACT TO AMEND THE FISHERIES (REGULATION OF FOREIGN FISHING

Be it enacted by the Parliament of the Democratic Socialist
Republic of Sri Lanka as follows:-

1. This Act may be cited as the Fisheries (Regulation of Foreign Fishing Boats) (Amendment) Act, No. of 2017. Short title.

5 2. The Fisheries (Regulation of Foreign Fishing Boats) Act, No. 59 of 1979 (hereinafter referred to as the “principal enactment”) is hereby amended by the substitution for the word “Secretary” wherever that word occurs in the principal enactment or any regulation, rule, notice or notifications of the word “Director-General”. General

3. Section 3 of the principal enactment is hereby amended as follows:- Amendment

(i) by the repeal of marginal note to that section and the substitution therefor of the following:-

15 “Armed forces etc. to co-operate in implementation and enforcement of this Act.”;

(ii) by the substitution for the words “ The commanders of the armed forces shall” of the words “The Commanders of the armed forces, the Director General of Coast Guard of the Department of Coast Guard established under Department of Coast Guard Act, No. 41 of 2009 and any other person designated by name or by office by the Minister in writing shall”.

4. Section 13 of the principal enactment is hereby amended as follows:-

“(4) (a) Any foreign fishing boat seized and detained under sub-paragraph (a) of subsection (2) or any abandoned foreign fishing boat; and

shall be brought to the nearest or most convenient port in Sri Lanka.”;

- 15 (ii) by the repeal of subsection (5) of that section and substitution therefor of the following:-

5 (iii) in subsection (6) of that section by the substitution for the words “Judge of the High Court” and “from the place of arrest to that Judge.” of the words “Magistrate” and “from the place of arrest to that of Magistrate.” respectively.

10 **5.** The following new sections are hereby inserted immediately after section 13 and shall have effect as sections 13A and 13B of the principal enactment:–

Insertion of new sections 13A and 13B in the principal enactment.

“Notice to consular officer on detention of foreign ship.

13A. (1) Whenever –

(a) any foreign fishing boat detained or seized under this Act; and

(b) any action is instituted under this Act against the master, owner or charterer if any, of a foreign fishing boat,

notice shall be forthwith served on the consular officer of the country to which the fishing boat belongs through the Minister to whom the subject of Foreign Affairs has been assigned.

(2) The grounds on which the boat has been seized or detained or on which the proceedings have been taken place, shall be specified in the notice to be served under subsection (1).

Liability for costs and damages.

13B. Notwithstanding anything contained in section 19B of this Act, if an abandoned foreign fishing boat is detained or seized under

Where any foreign fishing boat is used in the territorial waters, historic waters, public bays, rivers, lakes, lagoons, estuaries, streams, tanks, pools, ponds, channels or all other public inland or internal waters of Sri Lanka in contravention of the provisions of section 4, the master, owner and charterer, or any person on board of such boat shall each be guilty of an offence under this Act and shall each be liable on conviction by a Magistrate to an imprisonment for a term not exceeding two years or to a fine not less than the amounts specified in column II of the Schedule I hereto based on the length of the fishing boat specified in corresponding entry in the column I of the Schedule I hereto.

5 Conclusion of proceedings within one month. 15E. Any prosecution relating to any offence committed under this Act shall be concluded within one month from the date of institution of any such proceedings in the Magistrate's Court.

10 No person to be enlarged on bail. 15F. Notwithstanding anything to the contrary in the Code of Criminal Procedure Act, No. 15 of 1979, or any other written law, no person charged with, or accused of, an offence under sections 15 or 15A shall be enlarged on bail.

15 Retention of boat, fishing gear etc. until conclusion of trial. 15G. Subject to the provisions contained in the proviso to section 13 (5) any boat, fishing gear, equipment, stowed and cargo suspected to have been involved or used in the commission of any offence under sections 15, 15A, 15B, 15C and 15D shall not be released until conclusion of the trial.

10. Section 18 of the principal enactment is hereby amended, by the substitution for the words “the Court” of the words “the Magistrate’s Court”.

11. Section 19 of the principal enactment is hereby amended as follows:-

12. The following new sections are hereby inserted immediately after section 19 and shall have effect respectively as sections 19A , 19B and 19C of the principal enactment:-

Insertion of new sections 19A, 19B and 19C in the principal enactment.

“Abandoned foreign fishing boats.

19A. Where any abandoned foreign fishing boat, along with fishing gear, fish, aquatic plants, equipment, stores, and cargo is seized, on suspicion of being involved in the commission of an offence under this Act, it shall vest absolutely in the State unless a claim is being made to the said boat within the prescribed period.

Release of abandoned foreign fishing boat pursuant to an inquiry.

19B. (1) Where a claim is made to such abandoned foreign fishing boat, fishing gear, fish, aquatic plants, equipment, stores, and cargo by the owner, master or charterer if any of the boat within the period prescribed, the Magistrate upon being satisfied pursuant to an inquiry that such boat was not used for the commission of any offence under this Act shall make an order to release such boat or such items on board, or proceeds thereof, if it is sold consequent to an order made under section 13(5) of this Act to such claimant who has established his legal entitlement to such boat or any items on board before the Magistrate.

(2) The claimant shall pay all expenses incurred by the State in relation to the abandoned foreign fishing boat and all such items thereon.

When to consider an abandoned foreign fishing boat as a foreign fishing boat.

19C. Nothing contained in section 19A and 19B shall preclude an abandoned foreign fishing boat being considered as a foreign fishing boat for the purposes of any other provision of this Act including sections 15, 15A, 15B and 15C, in the event where an investigation reveals any person or an entity has contravened any other provision of this Act including sections 4 and 5.”.

13. Section 20 of the principal enactment is hereby repealed and the following section substituted therefor:-

Replacement of section 20 of the principal enactment.

“Compounding of offences.

20. (1) Where the Director-General has sufficient evidence to believe that any person has acted in contravention of the provisions of this Act, he may—

- (a) on the recommendation of the panel appointed under section 20A of this Act, in relation to any offence that was committed for the first time in the Exclusive Economic Zone of Sri Lanka;
- (b) having regard to the circumstances in which such contravention has taken place,

if it is appropriate to impose a penalty, cause a notice to be served in the prescribed form on such person, requiring him to appear within one month from the date of receipt of such notice and show cause why a penalty should not be imposed on him.

5 (2) Where the person on whom the notice is served appears within one month from the date of receipt of such notice and admits that he acted in contravention of the provisions of this Act, the Director-General shall impose on that person a penalty not exceeding one third of the maximum penalty that could be imposed under this Act to which such person could be liable to pay.

10 (3) Where a person on whom notice is served within one month from the date of receipt of such notice states that he has a cause to show against the imposition of the penalty, the Director General may proceed forthwith to hear and decide the matter in the manner prescribed.

15 (4) Where the Director- General is not satisfied with reasons given he may after assigning his own reasons therefore, impose the penalty specified in subsection (2) of this section.

20 (5) Where the Director-General imposes a penalty on any person under this section he shall cause a notice in the prescribed form to be served on such person indicating particulars of such penalty.

25 (6) Any person aggrieved by such decision of the Director-General may appeal to the Secretary to the Ministry of the Minister assigned the subject of Fisheries and Aquatic Resources Development (hereinafter referred to as the "Secretary") within thirty days from the date of receipt of such decision of the Director-General.

(7) The Secretary shall, after taking into consideration the decision of the Director-General and the circumstances in which the offence was committed may—

- 5 (a) affirm the decision of the Director-General and disallow the appeal;
- (b) set aside the decision of the Director-General and allow the appeal;
- 10 (c) allow the appeal subject to any amendment, alteration or variation of the decision of the Director-General.

15 (8) The decision of the Secretary shall be notified to the Director-General who shall take steps to comply with such decision within fourteen days from the date of communication of such decision to the Director-General.

(9) Such decision of the Secretary shall be communicated to the aggrieved party.

20 (10) Any person aggrieved by such decision of the Secretary may prefer any appeal to the Court of Appeal within thirty days from the date of communication of such decision, on a question of law.

25 (11) The compounding of any offence under this section shall be notified in writing under the signature of both parties to the Magistrate's Court and shall have effect of an acquittal of the accused.”.

5 “Appointment of a panel of experts. 20A. (1) The Director-General in consultation with the Secretary shall appoint a panel of experts consisting of three persons who have the knowledge expertise, and experience in the fields of marine engineering, Law and accountancy.

10 (2) It shall be the function of such panel to make recommendations to the Director-General, on the matters to be taken into account pertaining to compounding of an offence under section 20.

15 (3) The Minister shall pay such monetary remuneration as he shall determine in consultation with the Minister of Finance, to the members of the panel.”.

10 (ii) in subsection (2) of that section by the substitution for the words “A Judge of the High Court to whom” and “approved by the Judge,” of the words “A Magistrate to whom” and “approved by the Magistrate,”.

16. Section 23 of the principal enactment is hereby amended as follows:—

Amendment of section 23 of the principal enactment.

- 15 (i) by the renumbering of that section as subsection (1) of that section;
- (ii) by the insertion immediately after renumbered subsection (1) of the following subsections:—

20 “(2) Where any foreign fishing boat is found within any maritime zone of Sri Lanka and the fishing gear of such boat is not stowed in the prescribed manner or fish are found on board of such boat it may be presumed that the said boat has been used for fishing within the said Zone and for any purpose in contravention of the provisions of this Act until the contrary is proved.

25 (3) Where any abandoned foreign fishing boat is found it may be presumed to have been used for the commission of any offence under this Act until the contrary is proved.”.

Section 24 of the principal enactment is hereby amended, by the substitution for the words “be triable by the High Court sitting in any Judicial Zone of Sri Lanka.” of the words “be triable by a Magistrate having jurisdiction over the area or locality where the nearest or the most convenient port is situated.”.

18. Section 26 of the principal enactment is hereby amended by the substitution for paragraph (i) of subsection (2) of that section of the following:—

5 **20.** The following new section is hereby inserted immediately after section 27 and shall have effect as section 27A of the principal enactment:—

Insertion of new section 27A in the principal enactment.

“Establishment of the Reward Fund. 27A. (1) There shall be a fund which shall be called the Fisheries Reward Fund (hereinafter referred to as the “Reward Fund”).

10 (2) The Director-General shall be responsible for the administration of the Reward Fund.

(3) There shall be credited to the Reward Fund all proceeds realized from sales under section 19.

15 (4) The Director-General shall from time to time pay out of the Reward Fund a reward:—

(a) to any person as specified in section 3;

(b) to any authorized officer; or

20 (c) to any informer,

of such sum of money as he may deem fit:

Provided however, that such sum shall not exceed the maximum amount to be prescribed under this Act.

(5) The accounts of the Reward Fund shall be audited annually by the Auditor-General in accordance with Article 154 of the Constitution.”.
