AN ACT TO INCORPORATE THE MOHAN LANKA FOUNDATION

WHEREAS An Foundation called and known as the "Mohan Preamble. Lanka Foundation" has heretofore been formed in Sri Lanka, for the purpose of effectually carrying out its objects and transacting all matters connected with the said Foundation

5 according to the rules agreed to by its members:

AND WHEREAS the said Foundation has heretofore successfully carried out and transacted the several objects and matters for which it was established, and has applied to be incorporated and it will be for the public advantage to

10 grant the said application:

BE it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the Mohan Lanka Short title. Foundation (Incorporation) Act, No. of 2017.

- 2. (1) From and after the date of commencement of this Incorporation 15 Act, such and so many persons as now are members of the of the Mohan "Mohan Lanka Foundation" (hereinafter referred to as the Earnal "Foundation") or shall hereafter be admitted as members of the Corporation hereby constituted, shall be a body corporate
- 20 with perpetual succession, under the name and style of the "Mohan Lanka Foundation" (hereinafter referred to as the "Corporation") and by that name may sue and be sued, with full power and authority to have and use a common seal and to alter the same at its pleasure.
- (2) The Corporation shall be deemed to be a voluntary 25 social service organization within the meaning, and for the purpose of the Voluntary Social Service Organizations (Registration and Supervision) Act, No. 31 of 1980 and the provisions of that Act shall apply to and in relation to the

30 management of the affairs of the Corporation.

3. (1) The general objects for which the Corporation is General constituted are hereby declared to be -

Objects of the Corporation.

- (a) to grant various helps beginning from school education to university education to the children of families who face economic hardships;
- (b) to facilitate and sponsor the children who have lost their parents;
- (c) to facilitate and sponsor the differently able children;
- 10 (d) to conduct free medical camps;

- (e) to launch disaster management programmes and provide resources needful for such programmes;
- (f) to grant financial and meterial assistance to the youth clubs and sports clubs; and
- 15 (g) to do all such other acts and things as are necessary for an incidental or conducive to the attainment of the above objects.

(2) In the implementation of the objects specified in subsection (1) the Corporation shall ensure that such 20 implementation shall be carried out without any discrimination based on race, religion, language, caste, sex, political opinion, place of birth or any of such grounds.

4. 5. (1) Subject to the provisions of this Act, the Corporation Management shall be carried out by a Board of Directors (hereinafter of the Affairs of the referred to as "the Board") consisting of such number of Corporation. office bearers as may be specified by the rules made under 5 section 7.

(2) (a) The Board of Directors of the foundation that holds office on the day immediately preceding the date of commencement of this Act, shall function as the Board of the Corporation until the first Board is appointed or elected 10 in the manner provided for by rules made under section 7.

(b) The first Board of the Corporation shall be appointed or elected within one year of the date of commencement of this Act.

(3) (a) Every office bearer of the Board including the 15 patrons and advisors, shall be appointed or elected for a period of three years and any such office bearer, patron or advisor shall be eligible for re-appointment or re-election after lapse of the said period of three years.

(b) In the event of a vacancy occurring due to the death, 20 resignation, incapacity or removal from office of an office bearer, the Board shall having regard to the rules of the Corporation, elect or appoint a person to fill such vacancy.

(c) The person elected or appointed under paragraph (b)shall hold office only for the unexpired portion of the term 25 of office of the member whom he succeeds.

6. Subject to the provisions of this Act and any other Powers of the written law, the Corporation shall have the power to do, perform and execute all such acts and matters as are necessary or desirable for the promotion or any one of them, including

- (a) to purchase, acquire, rent, construct, renovate and otherwise obtain lands or buildings which may be required for the purpose of the Corporation and to deal with or dispose of the same as may be deemed expedient with a view to promoting the objects of the Corporation;
- (b) to raise funds, borrow moneys with or without security and receive grants, gifts or donations, in cash or kind:
- 10 Provided that, the Board shall obtain the prior written approval of the Department of External Resources of the Ministry of the Minister assigned the subject of Finance, in respect of all foreign grants, gifts or donations made to the Corporation;
- (c) to make, draw, accept, discount, endorse, negotiate, buy, sell and issue bills of exchange, cheques, promissory notes and other negotiable instruments and to open, operate and close accounts in any banks;
- 20 (d) to invest any funds not immediately required for the purposes of the Corporation in such manner as the Board may determine;
 - (e) to undertake, accept, execute, perform and administer any lawful trust or any real or personal property with a view to promoting the objects of the Corporation;
 - (f) to appoint, employ, dismiss or terminate the services of officers and servants of the Corporation and exercise disciplinary control over them and to pay them such salaries, allowances and gratuities as may be determined by the Corporation.

7. (1) It shall be lawful for the Corporation, from time to Rules of the Corporation. time, at any general meeting and by the votes of not less than two thirds of the members present and voting, to make rules, not inconsistent with the provisions of this Act or any 5 other written law, for all or any of the following matters:-(a)the classification of membership, admission, withdrawal, expulsion or resignation of members and fees payable by members; *(b)* the election of office bearers of the Board or 10 vacation of or removal from office of office bearers and the powers, duties and functions of the office bearers; the terms and conditions of appointments, powers, (c)functions and duties of the various officers, agents 15 and servants of the Corporation; (d)the procedure to be followed at the summoning and holding of meetings of the Board or any sub committee thereof, notices and agenda of such meetings, the quorum and the conduct of business

thereat:

- (e) the qualifications and disqualifications to be a member of the Board and the Corporation;
- (*f*) the administration and management of the property of the Corporation; and
- 25 (g) the management of the affairs of the Corporation and the accomplishment of its objects and dissolution of the Corporation.

(2) The rules made by the Corporation may be amended, altered, added to or rescinded at a like meeting and in like30 manner as a rule made under subsection (1).

(3) The members of the Corporation shall at all time be subject to rules of the Corporation.

(4) The rules made under this section shall be published in the *Government Gazette*.

(2) All moneys received by way of gift, bequest, donation,subscription, contribution, fees or grants for an account of the Corporation shall be deposited in one or more Banks approved by the Board to the credit of the Corporation.

(3) There shall be paid out of the Fund, all sums of money as are required to defray any expenditure incurred by the

15 Corporation in the exercise, performance and discharge of its powers, duties and functions under the Act.

10. (1) The financial year of the Corporation shall be Accounts and the calendar year.

(2) The Corporation shall cause proper accounts to be20 kept of incme and expenditure, assets and liabilities and all other transactions of the Corporation.

(3) The accounts of the Corporation shall be audited annually by a qualified auditor appointed by Auditor General in terms of Article 154 of the Constitution.

11. (1) The Board shall prepare a report of the activities Annual Report. of the Corporation for each financial year and submit such report together with the audited statement of accounts to

15 the Secretary of the Ministry of the Minister assigned the subject of Social Services and to the Registrar of Voluntary Social Services Organizations (Registration and Supervision) Act, No. 31 of 1980 before the expiration of six months of the year succeeding the year to which such 20 report relates.

(2) A separate accounts relating to the foreign and local moneys received by the Corporation during the financial year shall be attached to the report reffered to the subsection (1).

All debts and liabilities of the foundation existing Debts due by 25 on the day preceding the date of commencement of this Act, and payable shall be paid by the Corporation hereby constituted, and Foundation. all debts due to, and subscriptions and contributions payable to the Academy on that day shall be paid to the Corporation for the purpose of this Act.

13. Subject to the provisions of this Act, the Corporation Corporation shall be able and capable in law, to take and hold any property movable or immovable which may become vested in it by movable and virtue of any purchase, grant, gilft, testamentary disposition immovable.

(2) The seal of the Corporation shall be in the custody of an office bearer of the Board as may be decided by such Board.

16. (1) If upon the dissolution of the Corporation there Property 25 remains after the satisfaction of all its debts and liabilities, remaining on any property whatsoever, such property shall not be distributed among the members of the Corporation, but shall be given or transferred to any other institution having objects similar to those of the Corporation, and which is by the rules

30 thereof, prohibited from distributing any income or property among its members.
