AN ACT TO INCORPORATE THE ABDUL MAJEED ACADEMY

WHEREAS an Academy called and known as the Preamble. "Abdul Majeed Academy" has heretofore been formed in Sri Lanka for the purpose of effectually carrying out its objects and transacting all matters connected with the said Academy according to the rules agreed to by its members:

AND WHEREAS the said Academy has heretofore successfully carried out and transacted the several objects and matters for which it was established, and has applied to be incorporated and it will be expedient to grant the said

BE it therefore, enacted by the Parliament of the Democratic

1. This Act may be cited as the Abdul Majeed Academy Short title. (Incorporation) Act, No. of 2017.

- 2. (1) From and after the date of commencement of this Incorporation 15 Act, such and so may persons as now are members of the "Abdul of the Abdul Majeed Academy" (hereinafter referred to as the "Academy") or Academy. shall hereafter be admitted as members of the Corporation hereby constituted, shall be a body corporate with perpetual succession,
- 20 under the name and style of the "Abdul Majeed Academy", (hereinafter referred to as the "Corporation") and by that name may sue and be sued, with full power and authority to have and use a common seal and to alter the same at its pleasure.

(2) The Corporation shall be deemed to be a voluntary 25 social service organization within the meaning, and for the purpose of the Voluntary Social Service Organizations (Registration and Supervision) Act, No. 31 of 1980 and the provisions of that Act shall apply to and in relation to the management of the affairs of the Corporation.

3. (1) The general objects for which the Corporation is General objects of the Corporation.

- (*a*) to function as a fully-fledged higher educational institution;
- 5 (*b*) to offer lingual, technical, information technology and theological subjects;
 - (c) to conduct short-term and long-term courses on various disciplines;
 - (*d*) to conduct special and occasional lectures on topical issues;
 - (e) to motivate research, literature and writing;
 - (*f*) to publish books and periodicals giving guidelines on day-to-day affairs of the masses;
 - (g) to conduct guidance programmes;
- 15 (*h*) to provide counselling services on matters affecting the personal, family and social life;
 - (i) to propagate noble moral values; and
 - (*j*) to initiate, promote, facilitate and participate in development and advancement of education.
- 20 (2) In the implementation of the objects specified in subsection (1) the Corporation shall ensure that such implementation shall be carried out without any discrimination based on race, religion, language, caste, sex, political opinion, place of birth or any of such
- 25 grounds.

4. The objects of the Corporation shall be carried out in Corporation such manner so as not to create any conflict between the work of the Corporation and any work being carried out simultaneously by any Ministry or Department of the Ministry or

5 Government or any Provincial Council.

Corporation to ensure no conflict with the work of a Ministry or Department of the Central Government or Provincial Council.

5. (1) Subject to the provisions of this Act the Management Corporation shall be carried out by a Board of Directors of the affairs (hereinafter referred to as "the Board") consisting of such number of office bearers as may be specified by the rules

10 made under section 7.

(2) (*a*) The Board of Directors of the Foundation that holds office on the day immediately preceding the date of commencement of this Act, shall function as the Board of the Corporation until the first Board is appointed or elected15 in the manner provided for by rules made under section 7.

(*b*) The first Board of the Corporation shall be appointed or elected within one year of the date of commencement of this Act.

(3) (a) Every office bearer of the Board including the20 patrons and advisors, shall be appointed or elected for a period of three years and any such office bearer, patron or advisor shall be eligible for re-appointment or re-election after lapse of the said period of three years.

(b) In the event of a vacancy occurring due to the death,resignation incapacity or removal from office of an office bearer, the Board shall having regard to the rules of the Corporation, elect or appoint a person to fill such vacnacy.

(c) The person elected or appointed under paragraph (b) shall hold office only for the unexpired portion of the term30 of office of the member whom he succeeds.

6. Subject to the provision of this Act and any other powers of the written law, the Corporation shall have the power to do, perform and execute, all such acts and matters as necessary or desirable for the promotion, or any one of them, including

5 the power-

- (a) to purchase, acquire, rent, construct, renovate and otherwise obtain lands or buildings which may be required for the purpose of the Corporation and to deal with or dispose of the same as may be deemed expedient with a view to promoting the objects of the Corporation;
- (b) to raise funds and receive grants, gifts or donations, in cash or kind:

Provided that, the Board shall obtain the prior 15 written approval of the Department of External Resources of the Ministry of the Minister assigned the subject of Finance, in respect of all foreign grants, gifts or donations made to the Corporation;

- (c) to make, draw, accept, discount, endorse, negotiate, buy, sell and issue bills of exchange, cheques, 20 promissory notes and other negotiable instruments and to open, operate and close accounts in any bank;
 - (d) to invest any fund not immediately required for the purposes of the Corporation in such manner as the Board may determine ;
 - (e) to under, accept, execute, perform and administer any lawful trust or any real or personal property with a view to promoting the objects of the Corporation;

- (f) to appoint, employ, dismiss or terminate the services of officers and servants of the Corporation and exercise disciplinary control over them and to pay them such salaries, allowances and gratuities as may be determined by the Corporation; and
- (g) to do all other things as are necessary or expedient for the proper and effective carrying out the objects of the Corporation.
- 7. (1) It shall be lawful for the Corporation, from time to Rules of the corporation.

- 10 time, at any General Meeting and by the votes of not less ^{Corporation.} than two-thirds of the members present and voting, to make rules, not inconsistent with the provisions of this Act or any other written law, for all or any of the following matter:—
 - (*a*) the classification of membership, admission, withdrawal, expulsion or resignation of members and fees payable by members;
 - (b) the election of office bearers of the Board or vacation of or removal from office of office bearers and the powers, duties and functions of the office bearers;
 - (c) the terms and conditions of appointment, powers, functions and duties of the various officers, agents and servants of the Corporation;
 - (d) the procedure to be followed at the summoning and holding of meetings of the Board, or any subcommittee thereof, notices and agenda of such meetings, quorum and the conduct of business thereat;
- (e) the qualification and disqualification to be amember of the Board and the Corporation;
 - (*f*) the administration and management of the property of the Corporation; and

(g) the management of the affairs of the Corporation and the accomplishment of its' objects and dissolution of the Corporation.

(2) The rules made by the Corporation may be amended,altered, added to or rescinded at a like meeting and in like manner as a rule made under subsection (1).

(3) The members of the Corporation shall at all time be subject to rules of the Corporation.

(4) The rules made under this section shall be published 10 in the Government *Gazette*.

8. The Board shall maintain a register of members in Register of which names, addresses and other essential details of the members. members be inscribed.

9. (1) The Corporation shall have its own Fund. Fund of the Corporation.

15 (2) All moneys received by way of gift, bequest, donation, subscription, contribution, fees or grants for an account of the Corporation shall be deposited to in one or more Banks approved by the Board to the credit of the Corporation.

(3) There shall be paid out of the Fund all sums of moneyas are required to defray any expenditure incurred by the Corporation in the exercise, performance and discharge of its power, duties and functions under the Act.

10. (1) The financial year of the Corporation shall be Accounts and the calendar year.

25 (2) The Corporation shall cause proper accounts to be kept of income and expenditure, assets and liabilities and all other transactions of the Corporation.

(3) The accounts of the Corporation shall be audited by a qualified auditor appointed by Auditor-General in terms of30 Article 154 of the Constitution.

(4) For the purpose of this section, "Qualified Auditor" means -

- (a) an individual who being a member of the institute of Chartered Accountants of Sri Lanka, or any other institute established by law, possesses a certified to practice as an Accountant issued by the Council of such institute: or
- (b) a firm of Accountants each of the resident partners of which, being a member of the institute of Chartered Accountants of Sri Lanka or of any other institute established by law, possesses a certificate to practice as an Accountant issued by the Council of such institute.

11. (1) The Board shall prepare a report of the activities of the Annual Corporation for each financial year and submit such report together report. with the audited statement of accounts to the Secretary of the Ministry of the Minister as assigned the subject of Social Services

- 20 and to the Registrar of Voluntary Social Services Organizations appointed under the Voluntary Social Services Organization (Registration and Supervision) Act, No. 31 of 1980 before the expiration of six months of the year succeeding the year to which such report relates.
- 25 (2) A separate account relating to the foreign and local moneys received by the Corporation during the financial year shall be attached to the report referred to in subsection (1).
- 12. All debts and liabilities of the Academy existing on Debts due by 30 the day preceding the date of commencement of this Act, and payable to the shall be paid by the Corporation hereby constituted and all Foundation. debts due to, and subscriptions and contributions payable to the Academy on that day shall be paid to the Corporation for the purpose of this Act.

13. Subject to the provision of this Act, the Corporation Corporation shall be able and capable in law, to take and hold any property may hold movable or immovable which may become vested in it by movable and virtue of any purchase grant, gift, testamentary disposition immovable.

20 be independent of the signing of any person as a witness.

(2) The seal of the Corporation shall be in the custody of an office bearer of the Board as may be decided by such Board.

- **16.** (1) If upon the dissolution of the Corporation there Property 25 remains after the satisfaction of all its debts and liabilities remaining on any property whatsoever, such property shall not be dissolution. distributed among the members of the Corporation, but shall be given or transferred to any other institution having objects similar to those of the Corporation and which, is by
- 30 the rules thereof, prohibited from distributing any income or property among its members.

(2) For the purpose of this subsection (1) the appropriate institution shall be determined by the members of the Corporation immediately before the dissolution at a general
