AN ACT TO INCORPORATE THE ARAVIND KUMAR FOUNDATION

WHEREAS An Association called and known as the Preamble.
"Aravind Kumar Foundation" has heretofore been formed in Sri Lanka, for the purpose of effectually carrying out and transacting all objects and matters connected with the said
5 Foundation according to the rules agreed to by its members:

AND WHEREAS the said foundation has heretofore successfully carried out and transacted the several objects and matters for which it was formed and has applied to be incorporated and it will be for the public advantage to grant

10 such application:

BE it therefore enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

1. This Act may be cited as the Aravind Kumar Short title. Foundation (Incorporation) Act, No. of 2017.

- 15 2. From and after the date of commencement of this Incorporation Act, such and so many persons as now are members of the "Aravind Kumar Foundation" (hereinafter referred to as the "Foundation") or shall hereafter be admitted as members of the Corporation hereby constituted shall be a body corporate
- 20 (hereinafter referred to as the "Corporation") with perpetual succession under the name and style of "Aravind Kumar Foundation" and by that name may sue and be sued in all courts, with full power and authority to have and use a common seal and alter the same at its pleasure.

- (b) to advise and assist all communities in Sri lanka to live in peace and harmony;
- (c) to establish information technology centers for the advancement of scientific studies;
- (d) to implement social mobilization programmes and 5 educational and training programmes for the development of children and women;

- (e) to assist affected people in disaster situations to uplift their life style and providing legal assistance for needy vulnerable people;
- (f) to grant scholarships to needy school children to enable them to continue their education:
- (g) to assist in the development of educational, religious, cultural, aesthetic and sports facilities without any reference to race, religion or cast;
- (h) to promote ethics and culture, create necessary resources and maintain:
- (*i*) to take necessary steps to promote artistic creations, sport skills and technical knowledge of school leavers and set up vocational training centers ; and
- (*j*) to liaise and co-ordinate with other local or foreign institutions when have similar objects.

4. (1) The affairs of the Corporation shall, subject to the Management other provisions of this Act and the rules in force for the time of the affairs 25 being of the Corporation be administered by a Board of ^{of the} Corporation. Directors consisting of Chairman, Deputy Chairman,

Secretary, Treasurer and another eleven members elected in

accordance with such rules.

(2) The first Board of the Corporation shall consist of the members of the Board of Administration of the Foundation holding office on the day immediately preceding the date of commencement of this Act,

- 5. Subject to the provisions of this Act and any other General 5 written law, the Corporation shall have the power to do, Powers of the perform and execute all such acts, matters and things Corporation. whatsoever as are necessary or desirable for the promotion or furtherance of the objects of the Corporation or any one
- 10 of them, including to open, operate and close bank accounts, to borrow or raise moneys with or without security, and to engage, employ and dismiss officers and servants required for the carrying out of the objects of the Corporation.
- 6. (1) It shall be lawful for the Corporation, from time to Rules of the 15 time, at any General Meeting of the members and by a Corporation. majority of not less than two-thirds of the members present and voting, to make rules, not inconsistent with the provisions of this Act or any other written law, for all or any of the following matters:-
- (a) classification of membership, admission, 20 withdrawal, expulsion or resignation of members and membership fees payable;
 - (b) procedure to be observed for the summoning and holding of meetings of the Corporation and of the Board of Directors, the quorum for such meetings and the exercise and performance of their powers and duties:
 - (c) the appointments, powers, duties and functions of the various officers, agents and servants of the Corporation;
 - (d) qualification required to become a member of the Corporation and of the Board of Directors;and

(e) the administration and management of the property of the Corporation.

(2) Any rule made by the Corporation may be amended, altered, added to or rescinded at a like meeting and in like 5 manner as a rule made under subsection (1).

(3) Every member of the Corporation shall be subject to the rules of the Corporation.

7. All debts and liabilities of the Institute existing on Debts due by the day preceding the date of commencement of this Act, and payable 10 shall be paid by the Corporation hereby constituted and all to the foundation. debts due to subscriptions and contributions payable to the Foundation on that day shall be paid to the Corporation for the purposes of this Act.

8. (1) The Corporation shall have its own fund and all Fund of the 15 moneys heretofore or hereafter to be received by way of Corporation. gifts, bequests, donations, subscriptions, contributions, fees or grants for and on account of the corporation shall be deposited to the credit of the Corporation in one or more banks as the Board of Directors shall determine.

(2) There shall be paid out of the fund, all sums of money 20 required to defray any expenditure incurred by the Corporation in the exercise, performance and discharge of its powers, duties and functions under this Act.

9. The Corporation shall be able and capable in law to Corporation 25 acquire and hold any property, movable and immovable may hold which may become vested in it by virtue of any purchase, grant, lease, gift, testamentary disposition or otherwise and immovable. all such property shall be held by the Corporation for the purposes of this Act and subject to the rules in force for the

property movable and

30 time being of the Corporation, with full power to sell, mortgage, lease, exchange or otherwise dispose of the same.

10. If upon the dissolution of the Corporation there Property remains after the satisfaction of all its debts and liabilities remaining on any property whatsoever, such property shall not be dissolution. distributed among the members of the Corporation, but shall

5 be given or transferred to some other institution or institutions having objects similar to those of the Corporation and which, is or are by its or their rules prohibited from distributing any income or property among their members.

(2) The financial year of the Corporation shall be the calendar year.

(3) The accounts of the Corporation shall be examined15 and audited at least once in every year by an auditor or auditors appointed by the Board of Directors.

12. The seal of the Corporation shall not be affixed to Seal of the any instrument whatsoever except in the presence of such Corporation. number of persons as may be provided for in the rules in

20 force for the time being of the Corporation, who shall sign their names to the instrument in token of their presence and such signing shall be independent of the signing of any person as a witness.

13. Nothing in this Act contained shall prejudice or affect Saving of the 25 the rights of the Republic or of anybody politic, or corporate rights of the rights of the Republic and others.

14. In the event of any inconsistency between the Sinhala text Sinhala and Tamil texts of this Act, the Sinhala text shall to prevail in prevail.
