*STATEMENT OF LEGAL EFFECT*

*Clause 2* : This clause replaces section 4 of the Pradeshiya Sabha Act, No.15 of 1987 and the legal effect of the new section as replaced is to amend the composition of the Pradeshiya Sabhas.

AN ACT TO AMEND THE PRADESHIYA SABHA ACT, NO. 15 OF 1987

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

**1.** This Act may be cited as the Pradeshiya Sabha (Amendment) Act, No. of 2017. Short title.

5 **2.** Section 4 of the Pradeshiya Sabha Act, No. 15 of 1987 is hereby repealed and the following section substituted therefor:— Replacement of section 4 of Act, No. 15 of 1987.

“Composition of Pradeshiya Sabhas. **4.** (1) Each Pradeshiya Sabha shall consist of such number of members—

10 (a) as specified by the Minister by Order published in the *Gazette*, based on the Orders published under sections 3C and 3D of the Local Authorities Elections Ordinance (Chapter 262);

15 (b) equivalent to forty *per centum* of the number of members as specified by the Minister by Order made under paragraph (a), who shall be returned in terms of section 65B of the Local Authorities Elections Ordinance (Chapter 262); and

20 (c) determined by the Commissioner under paragraph (a) of subsection (4) of section 65B of the Local Authorities Elections Ordinance (Chapter 262).

2 *Pradeshiya Sabha (Amendment)*

5 (2) Where the number constituting forty *per centum* referred to in paragraph (b) of subsection (1), is an integer and fraction, the integer shall be deemed to be the number which shall constitute such forty *per centum*, for the purpose of that subsection.”

3. In the event of any inconsistency between the Sinhala and Tamil texts of this Act, the Sinhala text shall prevail. Sinhala text to prevail in case of inconsistency.
