STATEMENT OF LEGAL EFFECT

Clause 2: This clause replaces section 5 of the Urban Councils Ordinance (Chapter 255) and the legal effect of the new section as replaced is to amend the composition of the Urban Councils.

An ACT TO AMEND THE URBAN COUNCILS ORDINANCE (Chapter 255)

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

- 1. This Act may be cited as the Urban Councils Short title. (Amendment) Act, No. of 2017.
- 2. Section 5 of the Urban Councils Ordinance (Chapter Replacement 255) is hereby repealed and the following section substituted of section 5 therefor:-

- 5. (1) Each Urban Council shall consist of "Composition of Urban such number of Councillors— Councils.
- (a) as specified by the Minister by Order 10 published in the Gazette, based on the Orders published under sections 3c and 3p of the Local Authorities Elections Ordinance (Chapter 262);
 - (b) equivalent to forty per centum of the number of Councillors as specified by the Minister by Order made under paragraph (a), who shall be returned in terms of section 65B of the Local Authorities Elections Ordinance (Chapter 262); and
 - (c) determined by the Commissioner under paragraph (a) of subsection (4) of section 65B of the Local Authorities Elections Ordinance (Chapter 262).

- (2) Where the number constituting forty *per centum* referred to in paragraph (b) of subsection (1), is an integer and fraction, the integer shall be deemed to be the number which shall constitute such forty *per centum*, for the purpose of that subsection."
- **3.** In the event of any inconsistency between the Sinhala text and Tamil texts of this Act, the Sinhala text shall prevail.
