AN ACT TO INCORPORATE THE SOS CHILDREN'S VILLAGE OF SRI LANKA ORGANIZATION

WHEREAS an Organization called and known as the Preamble "S O S Children's Village of Sri Lanka Organization" has heretofore been formed in Sri Lanka for the purpose of effectually carrying out its objects and transacting all matters

5 connected with the said Organization according to the rules agreed to by its members:

AND WHEREAS the said Organization has heretofore successfully carried out and transacted the several objects and matters for which it was established, and has applied to

10 be incorporated and it will be expedient to grant the said application:

BE it therefore enacted by the Parliament of the Democratic 

1. This Act may be cited as the SOS Children's Village of Short title 15 Sri Lanka Organization (Incorporation) Act, No. of 2023

2. (1) From and after the date commencement of this Act, Incorporation such and so many persons as now are members of the S O S of the S O S Children's Children's Village of Sri Lanka Organization (hereinafter Village of Sri referred to as the "Organization") or shall hereafter be Lanka

- 20 admitted as members of the Corporation hereby constituted, shall be a body corporate with perpetual succession, under the name and style of the "S O S Children's Village of Sri Lanka Organization" (hereinafter referred to as the "body corporate") and by that name may sue and be sued, in all
- 25 Courts with full power and authority to have and use a common seal and to alter the same as its pleasure.

Organization

(2) The body corporate shall be deemed to be a voluntary social service organization within the meaning, and for the purpose of the Voluntary Social Service Organizations (Registration and Supervision) Act, No. 31 of 1980 and the provisions of that Act shall apply to and in relation to the management of the affairs of the Corporation.

**3.** The body corporate shall operates exclusively as a notfor- profit Organization and it is soley for the benefit of the society and its members. Body corporate operates as a not-for-profit

- Organization 4. (1) The general objects for which the body corporate is The General
  - The General objects of the body corporate
  - (a) to establish S O S Children's Village in the Island of Sri Lanka;
  - (b) to provide children living in S O S Children's Villages the total protection in the form of "family like care" model;
  - (c) to establish community centres, Hermann Gmeiner Schools and vocational training centres for mothers and children ;
- 20 (d) to establish youth villages and constructing houses for adolescent children who are under the protection of S O S Children's Villages ;
  - (e) to select and train mothers, caregivers and other employees for S O S Children's Villages ;
- 25 (f) to enlighten people, organizations and the general public on th concepts such as "protection

in the form family like care" and other children's welfare concepts through print, electronic and social media ; and

(g) to work in cooperation with the SOS Children's Villages International Organization and other local and foreign.

(2) In the implementation of the objects specified in subsection (1) the Corporation shall ensure that such implementation shall be carried out without any 10 discrimination based on race, religion, language, caste, sex, political opinion, place of birth or any of such grounds.

5. The objects of the Body corporate shall be carried out Body in such manner so as not to create any conflict between the corporate to ensure no work of the Corporation and any work being carried out conflict with 15 simultaneously by any Ministry or Department of the Ministry or Government or any Provincial Council.

6. (1) Subjects to the provisions of this Act, the Body Management corporate shall be carried out by a Board of Management of the Affairs of the body (hereinafter referred to as "the Board" consisting of such corporate

20 number of office bearers as may be specified by the rules made under Section 8.

(2) (a) The Board of Management of the foundation that holds office on the day immediately proceeding that date of commencement of this Act, shall function as the Board of the

25 Body corporate until the first Board is appointed or elected in the manner provided for by rules made under Section 8.

(b) The first Board of the Body corporate shall be appointed or elected within one year of the date of commencement of this Act.

(3) (a) Every office bearer of the Board including the patrons and advisors, shall be appointed or elected for a period of three years and any such office bearer, patron or advisor shall be eligible for re-appointment or re-election after lapse

of the said period of three years. 5

4

(b) In the event of a vacancy occurring due to the death, resignation, incapacity or removal from office of an office bearer, the Board shall having regard to the rules of the Corporation, elect or appoint a person to fill such vacancy.

(c) The person elected or appointed under paragraph (b) 10 shall hold office only for the unexpired portion of the term of office of the member whom he succeeds.

7. Subject to the provisions of this Act and any other Powers of the written law, the Body corporate shall have the power to do,

- 15 perform and execute all such acts and matters as necessary or desirable for the promotion or any one of them, including the power -
  - (a) to purchase, acquire rent, construct, renovate and otherwise obtain lands or buildings which may be required for the purpose of the Body corporate and to deal with or dispose of the same as may be deemed expedient with a view to promoting the objects of the Body corporate ;
  - (b) to raise funds and receive grants, gifts or donations, in cash or kind with or without security :

Provided that, the Committee shall obtain the prior written approval of the Department of External Resources of the Ministry of the Minister assigned the subject of Finance, in respect of all foreign grants, gifts or donations made to the Body corporate.

- (c) to make, draw, accept, discount, endorse, negotiate, buy, sell and issue bills of exchange, cheques, promissory notes and other negotiable instruments and to open, operate and close accounts in any banks;
- (d) to invest any funds not immediately required for the purposes of the Body corporate in such manner as the Committee may determine;
- (e) to undertake, accept, execute, perform and administer any lawful trust or any real or personal property with a view to promoting the objects of the Body corporate;
- (f) to appoint, employ, dismiss or terminate the services of officers and servants of the Body corporate and exercise disciplinary control over them and to pay them such salaries, allowances and gratuities as may be determined by the Body corporate;
- (g) to do all other things as are necessary or expedient for the proper and effective carrying out the objects of the Body corporate.

8. (1) It shall be lawful for the Body corporate, from time Rules of the to time, at any general meeting and by the votes of not less Body corporate than two thirds of the members present and voting, to make rules, not inconsistent with the provision of this Act or any

- - (a) the classification of membership, admission, withdrawal, expulsion or resignation of members and fees payable by members ;

- (*b*) the election of office bearers of the Board or vacation of or removal from office of office bearers and the powers, duties and functions of the office bearers;
- (c) the terms and conditions of appointment, powers, functions and duties of the various officers, agents and servants of the Body corporate;
- (d) the procedure to be followed at the summoning and holding of meetings of the Board, or any subcommittee thereof, notices and agenda of such meetings, the quorum and the conduct of business thereat;
- (*e*) the qualification and disqualification to be a member of the Board and the Body corporate;
- (*f*) the administration and management of the property of the Body corporate ; and
- (g) the management of the affairs of the Body corporate and the accomplishment of its' objects and dissolution of the Corporation.

(2) The rules made by the Body corporate may be amended,altered, added to or rescinded at a like meeting and in like manner as a rule made under subsection (1).

(3) The members of the Body corporate shall at all time be subject to rules of the Body corporate.

(4) The rules made under this Section shall be published 25 in the *Government Gazette*.

**9.** The Board shall maintain a register of members in Register of which name, address and other essential details of the members be inscribed.

**12.** (1) The Board shall prepare a report of the activities of the Body corporate for each financial year and submit such report together with the audited statement of accounts to the Secretary of the Ministry of the Minister assigned the subject of Social Services and to the Registrar of Voluntary Social Services Organizations appointed under the Voluntary Social Services Organizations (Registration and Supervision) Act, No. 31 of 1980 before the expiration of six months of the year succeeding the year to which such report relates.

- (2) A separate account relating to the foreign and local 10 moneys received by the Body corporate during the financial year shall be attached to the report referred to in subsection (1).
- 13. All debts and liabilities of the Foundation existing Debts due by 15 on the day preceding the date of commencement of this Act, and payable shall be paid by the Body corporate hereby constituted, and foundation all debts due to, and subscriptions and contributions payable to the Foundation on that day shall be paid to the Body corporate for the purpose of this Act.
- 14. Subject to the provisions of this Act, the Body corporate Body 20 shall be able and capable in law, to take and hold any property movable or immovable which may become vested in it by virtue of any purchase grants, gifts, testementary dispositions or otherwise, and all such property shall be held by the Body
- 25 corporate for the purposes of this Act, and subject to the rules of the Body corporate made under section 7, with power to sell, mortgage, lease, exchange or otherwise dispose of the same.
- 15. The moneys and property of the Body corporate Application 30 however derived shall be applied solely towards the promotion of the objects of the Body corporate and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or profit to the members of the Body corporate.

(1) The seal of the Body corporate shall not be affixed Seal of the to any instrument whatsoever, except in the presence of two body corporate members of the Board who shall sign their names to the instrument in token of their presence and such signing shall be independent of the signing of any person as a witness. (2) The seal of the Body corporate shall be in the custody of an office bearer of the Board as may be decided by such Board. **17.** (1) If upon the dissolution of the Body corporate Property 10 there remains after the satisfaction of all its debts and remaining on dissolution liabilities, and property whatsoever, such property shall not be distributed among the members of the Body corporate, but shall be given or transferred to any other institution having objects similar to those of the Body corporate, and 15 which is by the rules thereof, prohibited from distributing any income or property among its members. (2) For the purpose of this subsection (1) the appropriate institution shall be determinded by the members of the Body corporate immediately before the dissolution at a general 20 meeting by the majority of votes of the members prsent. 18.
