*STATEMENT OF LEGAL EFFECT*

*Clause 2* : This clause amends section 2 of the Appropriation Act, No. 43 of 2022 (hereinafter referred to as the “principal enactment”) in paragraph (b) of subsection (1) by increasing the borrowing limit of rupees 4,979 billion to rupees 13,979 billion and in subsection (4) by increasing the service expenditure of rupees 4,222,233,362,000 to rupees 13,222,233,362,000.

*Clause 3* : This clause amends the *Capital Expenditure* of the Department of Treasury Operations appearing under the *Head No.* 249 of the Second Schedule to the principal enactment by increasing the amount of rupees 2,019,970,000,000 to rupees 11,019,970,000,000.

AN ACT TO AMEND THE APPROPRIATION ACT, NO. 43 OF 2022

BE it enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows: -

1. This Act may be cited as the Appropriation (Amendment) Act, No. of 2023. Short title

5 2. Section 2 of the Appropriation Act, No. 43 of 2022 (hereinafter referred to as the “principal enactment”) is hereby amended as follows:- Amendment of section 2 of Act, No.43 of 2022

(1) in paragraph (b) of subsection (1) of that section, by the substitution for the words “rupees four thousand nine hundred seventy nine billion”, of the words “rupees thirteen thousand nine hundred seventy nine billion”; and

(2) in subsection (4) of that section, by the substitution for the words “rupees four thousand two hundred twenty two billion two hundred thirty three million three hundred sixty two thousand”, of the words “rupees thirteen thousand two hundred twenty two billion two hundred thirty three million three hundred sixty two thousand”.

20 3. The *Capital Expenditure* Column of the Department of Treasury Operations appearing under the *Head No. 249* of the Second Schedule to the principal enactment is hereby amended by the substitution for the figures “2,019,970,000,000” of the figures “11,019,970,000,000”.
