AN ACT TO INCORPORATE THE MABOTUWANA SRI PIYARATHANA NAYAKA THERO SUWASEVANA FOUNDATION

WHEREAS an Foundation called and known as the Preamble "Mabotuwana Sri Piyarathana Nayaka Thero Suwasevana Foundation" has heretofore been formed in Sri Lanka for the purpose of effectually carrying out its objects and transacting 5 all matters connected with the said Trust according to the rules agreed to by its members:

AND WHEREAS the said foundation has heretofore successfully carried out and transacted several objects and matters for which it was established, and has applied to 10 be incorporated, and it will be expedient to grant the said application:

BE it therefore, enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:-

- 1. This Act may be cited as the Mabotuwana Short title 15 Sri Piyarathana Nayaka Thero Suwasevana Foundation (Incorporation) Act, No. of 2025.
- 2. From and after the date of commencement of this Incorporation act, such and so many persons as now are members of the Mabotuwana Sri Piyarathana Nayaka Thero Suwasevana 20 Foundation (hereinafter referred to as the "Foundation") or shall hereafter be admitted as members of the Corporation hereby constituted, shall be a body corporate with perpetual Foundation succession, under the name and style of the "Mabotuwana Sri Piyarathana Nayaka Thero Suwasevana Foundation" 25 (hereinafter referred to as the "body corporate") and by that name may sue and be sued, with full power and authority to have and use a common seal and alter the same at its pleasure.

3. (1) The general objects for which the body corporate The General is constituted are hereby declared to be-

objects of the body corporate

(a) to give temporary residential facilities to patients from various areas of Sri Lanka suffering from dreadful non - communicable diseases to the Karapitiya Hospital for treatment;

- (b) to provide assistance and support through the implementation of programmes for the advantage of the differently abled and children with special needs:
- (c) to operate a library for making available library facilities for the mental comfort of residents;
- (d) to provide the residents with a meal prepared in a safe manner and according to proper standard free 15 of charge;
 - (e) to provide each patient facilities separately, such as fridges necessary to properly store medicines etc, that should be administered daily to patients and operating a support service to give each patient the prescribed doses of medicine at the specified
 - (f) to provide free accommodation facilities to relatives, friends or acquaintances accompanying patients and providing them with meals free of charge;
 - to provide financial aid in the case of poor and helpless patients who cannot afford the medicine prescribed to them; and

- (h) to act in cooperation with local and foreign people and organizations who are willing to work for helpless patients.
- (2) In the implementation of the objects specified 5 in subsection (1) the Corporation shall ensure that such implementation shall be carried out without any discrimination based on race, religion, language, caste, sex, political opinion, place of birth or any of such grounds.
- 4. The objects of the body corporate shall be carried Body 10 out in such manner so as not to create any conflict between the work of the Corporation and any work being carried no conflict out simultaneously by any Ministry or Department of the with work of Government or any Provincial Council.

5. (1) Subject to the provisions of this Act the body Management 15 corporate shall be carried out by a Board of Management of the affairs (hereinafter referred to as "the Board") consisting of such corporate number of office bearers as may be specified by the rules made under section 7.

- (2) (a) The Board of Management of the foundation that 20 holds office on the day immediately preceding the date of commencement of this Act, shall function as the Board of the body corporate until the first Board is appointed or elected in the manner provided for by rules made under section 7.
- (b) The first Board of the body corporate shall be appointed 25 or elected within one year of the date of commencement of this Act.

- (c) Subject to the provision of clause 7, the Interim Board of the body corporate shall have the power to make rules for the interim administration of the body corporate by majority consent, not inconsistent with the provisions of this Act or any other written laws.
- (3) (a) Every office bearer of the Board including the patrons and advisors, shall be appointed or elected for a period of three years and any such office bearer, patron or advisor shall be eligible for re-appointment or re-election 10 after lapse of the said period of three years.
 - (b) In the event of a vacancy occurring due to the death, resignation, incapacity or removal from office of an office bearer, the Board shall having regard to the rules of the Corporation, elect or appoint a person to fill such vacancy.
- (c) The person elected or appointed under paragraph (b) 15 shall hold office only for the unexpired portion of the term of office of the member whom he succeeds.
- 6. Subject to the provisions of this Act and any other Powers of written law, the body corporate shall have the power to do, the body 20 perform and execute all such acts and matters as necessary or desirable for the promotion or any one of them, including the power—

(a) to purchase, acquire, rent, construct, renovate and otherwise obtain lands or buildings which may be required for the purpose of the body corporate and to deal with or dispose of the same as may be deemed expedient with a view to promoting the objects of the body corporate;

(b) to raise funds and receive grants, gifts or donations, in cash or kind with or without security:

Provided that, the Board shall obtain the prior written approval of the Department of External Resources of the Ministry of the Minister assigned the subject of Finance, in respect of all foreign grants, gifts or donations made to the body corporate;

- (c) to make, draw, accept, discount, endorse, negotiate, buy, sell and issue bills of exchange, cheques, promissory notes and other negotiable instruments and to open, operate and close accounts in any banks;
- (d) to invest any funds not immediately required for the purposes of the body corporate in such manner as the Board may determine;
- (e) to undertake, accept, execute, perform and 15 administer any lawful trust or any real or personal property with a view to promoting the objects of the body corporate;
- (f) to appoint, employ, dismiss or terminate the services of officers and servants of the body corporate and 20 exercise disciplinary control over them and to pay them such salaries, allowances and gratuities as may be determined by the body corporate;
- (g) to do all other things as are necessary or expedient for the proper and effective carrying out the objects 25 of the body corporate.

7. (1) It shall be lawful for the body corporate, from time Rules of to time, at any general meeting and by the votes of not less the body than two thirds of the members present and voting, to make corporate 30 rules, not inconsistent with the provisions of this Act or any other written law, for all or any of the following matters:-

 - (a) the classification of membership, admission, withdrawal, expulsion or resignation of members and fees payable by members;
- (b) the election of office bearers of the Board or vacation of or removal from office of office bearers and the powers, duties and functions of the office bearers;
 - (c) the terms and conditions of appointment, powers, functions and duties of the various officers, agents and servants of the body corporate;

- (d) the procedure to be followed at the summoning and holding of meetings of the Board, or any sub-committee thereof, notices and agenda of such meetings, the quorum and the conduct of business thereat;
- (e) the qualification and disqualification to be a member of the Board and the body corporate;
- (f) the administration and management of the property of the body corporate; and
- 20 (g) the management of the affairs of the body corporate and the accomplishment of its' objects and dissolution of the body corporate.
- (2) The rules made by the body corporate may be amended, altered, added to or rescinded at a like meeting and in like manner as a rule made under subsection (1).
 - (3) The members of the body corporate shall at all time be subject to rules of the body corporate.

- (4) The rules made under this section shall be published in the Government Gazette.
- (5) Every rule made by the body corporate shall within three months of its publication in the Gazzette be brought 5 before Parliament for approval. Any rule which is not so approved shall be deemed to be rescinded as from the date of such disapproval, but without prejudice to anything previously done thereunder.
- 8. The Board shall maintain a register of members in Register of 10 which name, address and other essential details of the members members be inscribed.

9. (1) The body corporate shall have its own Fund.

Fund of the body corporate

- (2) All moneys received by way of gift, bequest, donation, subscription, contribution, fees or grants for an account of 15 the body corporate shall be deposited in one or more banks approved by the Board to the credit of the Corporation.
- (3) There shall be paid out of the Fund all sums of money as are required to defray any expenditure incurred by the body corporate in the exercise, performance and discharge 20 of its powers, duties and functions under the Act.
 - 10. (1) The financial year of the body corporate shall be Accounts and the calendar year.

the auditing

- (2) The body corporate shall cause proper accounts to be kept of income and expenditure, assets and liabilities and all 25 other transactions of the body corporate.
 - (3) The accounts of the body corporate shall be audited by a qualified auditor appointed by Auditor General in terms of Article 154 of the Constitution.

- (4) For the purpose of this section "qualified auditor" means-
 - (a) an individual who being a member of the Institute of Chartered Accountants of Sri Lanka, or any other institute established by law, possesses a certificate to practice as an Accountant issued by the Council of such institute; or
- (b) a firm of Accountants each of the resident partners of which, being a member of the Institute of Chartered Accountants of Sri Lanka or of any other institute established by law, possesses a certificate to practice as an Accountant issued by the Council of such institute.
- 11. (1) The Board shall prepare a report of the activities Annual Report 15 of the body corporate for each financial year and submit such report togother with the audited statement of accounts to the Secretary of the Ministry of the Minister assigned the subject of Social Services and to the Registrar of Voluntary Social Services Organizations appointed under the Voluntary 20 Social Services Organization (Registration and Supervision) Act, No. 31 of 1980 before the expiration of six months of the year succeeding the year to which such report relates.
- (2) A separate account relating to the foreign and local moneys received by the body corporate during the financial year shall be attached to the report referred to in subsection (1).
 - 12. All debts and liabilities of the Foundation existing Debts due on the day preceding the date of commencement of this Act, by and shall be paid by the body corporate hereby constituted, and payable to the all debts due to, and subscriptions and contributions payable to the Foundation on that day shall be paid to the body corporate for the purpose of this Act.

13. Subject to the provision of this Act, the body corporate Body shall be able and capable in law, to take and hold any property movable or immovable which may become vested in it by movable and virtue of any purchase, grant, gift, testamentary disposition immovable or otherwise, and all such property shall be held by the body corporate for the purposes of this Act, and subject to the rules of the body corporate made under section 7, with power to sell, mortgage, lease, exchange or otherwise dispose of the same.

14. The moneys and property of the body corporate Application 10 however derived shall be applied solely towards the promotion of the objects of the body corporate and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or profit to the members of the body 15 corporate.

15. (1) The seal of the body corporate shall not be affixed Seal of the to any instrument whatsoever, except in the presence of two members of the Board who shall sign their names to the instrument in token of their presence and such signing shall 20 be independent of the signing of any person as a witness.

corporate

- (2) The Seal of the body corporate shall be in the custody of an office bearer of the Board as may be decided by such Board.
- **16.** (1) If upon the dissolution of the body corporate there Property 25 remains after the satisfaction of all its debts and liabilities, remaining on any property whatsoever, such property shall not be distributed among the members of the body corporate, but shall be given or transferred to any other institution having objects similar to those of the body corporate, and which is 30 by the rules thereof prohibited from distributing any income or property among its members.

dissolution

- (2) For the purpose of this subsection (1) the appropriate institution shall be determined by the members of the body corporate immediately before the dissolution at a general meeting by the majority of votes of the members present.
- 5 17. Nothing in this Act contained shall prejudice or affect Saving of the the rights of the Republic or of anybody politic or corporate.

Rights of the Republic and others

18. In the event of any inconsistency between the Sinhala sinhala text and Tamil texts of this Act, the Sinhala text shall prevail.
