NATIONAL WATER SUPPLY AND DRAINAGE BOARD ACT, No. 02 OF 1974

Order under Section 64(1)

BY virtue of the powers vested in me by Section 64(1) of the National Water Supply and Drainage Board Act, No. 2 of 1974, I, Dinesh Gunawardena, the Minister of Water Supply and Drainage, do by this order embody in the Schedule hereto, the provisions of the Voluntary Transfer Scheme approved by me under Section 63(1) of the aforesaid Law, in respect of the water supply undertakings on Dambawela, Elhena, Maligawatta, Sarasavigama, Ogastawatta, Udabowala, Mahakanda, Hindagala and Udaperadeniya maintained by the Kandy Four Gravets Pradeshiya Sabha.

SCHEDULE

Contents of the Voluntary Transfer Scheme Section 61(1) :

- (a) The following movable and immovable property to be transferred to and vested in the National Water Supply and Drainage Board to wit,
- (i) All water sources, service reservoirs, water treatment plants and balancing tanks which belong to the Dambewela, Elhena, Mailgawatta, Sarasavigama, Ogastawatta, Udabowala, Mahakanda, Hindagala and Udaperadeniya Water Supply Scheme of the Kandy Four Gravets and all lands, structures, water mains and installments of all the mechanical, electrical plant and machinery to operate and maintain the service reservoirs, pumping stations together with all spares, standby equipment and stores required for the maintenance of such machinery.

- (ii) All trunks and distribution main together with servitude for water mains, spares standby equipment and stores necessary to operate and maintain the water supply scheme of Kandy Four Gravets.
- (b) The rights, obligations and liabilities of the Kandy Four Gravets Pradeshiya Sabha together with any contract the council has entered into in connection with design, supply, installation, construction, operation and maintenance with respect of the aforesaid property will also be transferred to the Board.
- (c) All agreements entered into with water consumers with regard to conditions of the use and supply of water services and payments to obtain such services will also be transferred to the Board.
- (d) The assets of these facilities valued at Rs. 3,411,900.00 (Rupees Three Million Four Hundred and Eleven Thousand Nine Hundred) will be provided on a grant to the Board by the Government.
- (e) All agreements entered into by the Pradeshiya Sabha in connection with water supply will also continue and honoured by the Board.
- (f) The above transfer will come into effect from the date of publication of this notice.
