FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE KALMUNAI MUNICIPAL COUNCIL UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of a Member in Kalmunai Municipal Council has fallen vacant by reason of being elected as a member of the Parliament ;
