Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 2

I, Janaka Bandula Theerakoon, Minister of Lands and Land Development, hereby declare under sub-section (1) of Section 2 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land shown as Lots 'A', 'B', 'C', 'D', 'E' and 'F' in the attached map, being in an area of about 0.1250 Hectare, depicted in Advance Tracing No. KUK/KR/2011/37, prepared by the Surveyor-General, situated in the Village of Gellawa in the Minor Division of Rekombaththawa, in the Divisional Secretary's Division of Kurumbela, Kurumbela District in North Western Province and bounded as follows:

1. Lot 'A' - Magunawatta - Extent: About 0.0012 Hectare
North: Road (RDA) ; East: Road (R2) ; South: Balance portion of same land and Magunawatta claimed by W. M. Niyas Kadar; West: Lot No B.

2. Lot 'B' - Magunawatta - Extent: About 0.0032 Hectare
North: Road (RDA) ; East: Lot A and Magunawatta claimed by W. M. C. N. Priyathirika ; South: Balance portion of same land ; West: Road (R2).

3. Lot 'C' - Magunawatta - Extent: About 0.0021 Hectare
North: Road (RDA) ; East: Road (R2) ; South: Balance portion of same land and Magunawatta claimed by H. D. Stejneger de Silva; West: Lot D.

4. Lot 'D' - Magunawatta - Extent: About 0.0022 Hectare
North: Road (RDA) ; East: Lot C and Magunawatta claimed by H. A. Anil Kumarasakara; South: Balance portion of same land and Magunawatta; West: Magunawatta.
