THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a Public purpose and will be acquired under the provisions of that Act.

Eight (08) allotments of lands in total extent of about 1.4034 Hectare depicted in Advance Tracing No. Co/DSO/2012/334 dated 21.01.2013 prepared by the Surveyor -General, situated in the Village of Pepiliyana in the Kesbawa Divisional Secretary's Division in Colombo District, in Western Province and bounded as follows:

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Six (6) allotments of land in total extent of about 16.861 Hectares, depicted in the Advance Tracing No. Co/ DSO/ 2012/ 960 dated 21.01.2013 prepared by the Surveyor General situated in the Village of Boralesgamuwa in the Divisional Secretary's Division of Kesbewa of Colombo District in Western Province and bounded as follows:
