**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE WENNAPPUWA PRADESHIYA SABHA
UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)**

WHEREAS, the office of a Member in Wennappuwa Pradeshiya Sabha has fallen vacant by reason of being elected as a member of the North Western Province Provincial Council :
