ORDER UNDER PROVISIO (A) TO SECTION 38

1. **Land Acquiring Officer.** - Divisional Secretary, Kayts.

2. **Description of the land** - An Allotment of land called "Arulmeehu Sri Sangaranathar Maha Kanapathipillaiyar Kovil Land" in total extent of about 0.0500 Hectare depicted as Lot "A" in the Advance Tracing No. Ya/KYT/2012/77 dated 27.04.2012 prepared by the Surveyor General, situated in the Village called Analathivu in the Grama Niladari Division of Analathivu North J/ 37 in the Divisional Secretary's Division of Kayts of Jaffna District in Northern Province and bounded as follows:
