Contents of Voluntary Transfer Scheme Section 61 (1)

- (a) The following movable and immovable property to be transferred to and vested in the National Water Supply and Drainage Board to wit ;

All trunks and distribution mains with servitude for water mains, spares standby equipment and stores accessories to operate and maintain the Water Supply Scheme situated within the limits of Matara Pradeshiya Sabha area mention in the following schedule ;

- (b) The rights, obligations and liabilities of the Matara Pradeshiya Sabha together with any contract the council has entered in to in connection with design, supply, installation, constructions, operation and maintenance with respect of the aforesaid property will also be transferred to the Board ;

- (c) All agreements entered in to with water consumers with regard to conditions of the use and supply of water services and payment to obtain such services will also be transferred to the Board ;

- (d) The assets of these facilities valued at Rs. 8,313,442 (Rupees Eight Million Three Hundred Thirteen Thousand Four Hundred and Forty Two) will be provided on grant to the Board by the Government.
- (e) All agreements entered in to by the Pradeshiya Sabha in connection with Water Supply will also be continued and honored Board.
