**CIVIL AVIATION ACT, NO. 14 OF 2010**

REGULATIONS made by the Minister of Civil Aviation by virtue of powers vested in me under Section 117 (q) of the Civil Aviation Act, No. 14 of 2010.

**Regulations**

1. These Regulations may be cited as Aeronautical Service Charges at Mattala Rajapaksha International Airport.
2. Unless otherwise exempt by Director General of Civil Aviation in writing,
  - (a) every aircraft operating International commercial air services into and out of Mattala Rajapaksa International Airport shall pay the following Landing charges and Parking Charges to the Statutory Service Provider.

01	Landing Charges	United State's Dollars 4.00 per Metric Tonne of the Maximum Take-off Weight of the aircraft or part thereof, subject to a minimum charge of United State's Dollars 250 per landing.
02	Parking Charges	10% of the applicable Landing charge for a period of 06 hours or part thereof in excess of 1st three hours of parking after landing.

- (b) every aircraft operating domestic commercial air services into and out of Mattala Rajapaksa International Airport shall pay the following charges to the Statutory Service Provider.

01	Landing Charges	Rs. 200.00 per Metric Tonne of the Maximum Take-off Weight of the aircraft or part thereof, subject to a minimum of 2,500 per landing.
02	Parking Charges	10% of the applicable Landing charge for a period of 06 hours or part thereof in excess of 1st three hours of parking after landing.

Notwithstanding the paragraph 2 (a) above, every international airline operating into and out of Mattala Rajapaksa International Airport will be afforded with the following discounted rates in regard to the applicable Landing Charges, Parking Charges and Ground Handling Charges with immediate effect.
