## PART I : SECTION (I) — GENERAL

### Government Notifications

#### NOTICE UNDER THE REGISTRATION OF ELECTORS ACT, No. 44 OF 1980 AS AMENDED BY THE REGISTRATION OF ELECTORS (SPECIAL PROVISIONS) ACT, No. 27 OF 2013

CERTAIN persons have been internally displaced as a result of any actions of a terrorist militant or other group during the recent past :

02. In terms of Section 2 of the Registration of Electors (Special Provisions) Act, No. 27 of 2013 any person,

- 2.1 who is or had been an internally displaced,
- 2.2 whose name appeared in the register of electors for any electoral district in the Northern Province or Eastern Province for any year, until the end of the year 2009 ; and,
- 2.3 whose name has not been entered in any register in operation subsequent to the year 2009,

shall on proof of the matters specified in above paragraphs and on production of a certificate issued by the Grama Niladhari of the area in which the applicant is presently residing, to the effect that the applicant is or the applicant had been an internally displaced person, be entitled to apply to the registering officer of the electoral district within which the applicant was permanently resident prior to 18th May 2009 to be registered in the register of electors of such electoral district.

03. In terms of the Section 3 of the Special Provisions Act, children of Sri Lankan citizen mentioned in paragraph 2 above,

- 3.1 who had not attained the age of eighteen years on the date on which such citizens became an internally displaced and have attained the age of eighteen years or more on the date on which the revision of the operative register commenced, at the time in which the application is made,
- 3.2 who were born after such citizen became an internally displaced person and have attained the age of eighteen years or more on the date on which the revision commenced in respect of the register in operation, at the time in which the application is made,
- 3.3 whose name has not been entered in any register in operation subsequent to the year 2009,

on production of the birth certificate of such children sought to be registered and a certificate issued by the Grama Niladhari of the area in which the applicant is presently residing on proof of the matters mentioning

that parents had been internally displaced persons prior to 18th May 2009, be entitled to apply to the registering officer of the electoral district within which the applicant was permanently resident prior to be registered in the register of electors of such electoral district,

04. It is hereby notified that in terms of the powers vested in me under 2(1) of the Registration of Electors (Special Provisions) Act, No. 27 of 2013, applications are called from persons qualifying under paragraph 02 and 03, in order to be included in a supplementary register for the North and Eastern Provinces for the year 2012 during the period commencing from on 22nd June, 2013 and ending on 28th June, 2013. Relevant application forms can be obtained from offices of the Registering Officer of all the Electoral Districts Island wide and duly filled applications should be forwarded to the Registering Officer of the Electoral Districts located in North and Eastern Provinces (Jaffna, Vavuniya, Batticaloa, Digamadulla and Trincomalee).

05. It is further notified that completion of the Supplementary Register mentioned in the paragraph 04 is scheduled to end on 28th June and the announcement regarding the completion to be made on the 29th June. Persons whose names were qualified to be included in the Supplementary Register but not included in such Register are to be given a period of 07 days from such date to submit their appeal.
