I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, as Amended by the Land Acquisition (Amendment) Act, No.28 of 1964, that the Government intends to acquire the following land which is required for a public purpose.

**Description of the land to be acquired:**

Three allotments of land called Kalemudara Ovita and Pitakattiya in total extent 0.3379 Hectare depicted as lot No. 1, 2 and 3 in Preliminary Plan No. P.P.Ka 4393 prepared by the Surveyor-General situated in the village of Pahalagoda in Grama Niladhari Division of 815B Pahalagoda in the Divisional Secretary's Division of Madurawala in Kalutara District Western Province.
