SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, read with Article 44 (2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, I, Mahinda Rajapaksa, President of the Democratic Socialist Republic of Sri Lanka, do by this Order impose in respect of the commodity items specified in Column I of the Schedule hereto a Special Commodity Levy, at the rates specified in the corresponding entries in Column II of that Schedule. This Order shall be valid for a period of 05 months commencing from 02nd August 2013, subject to provisions of subsection (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

Order made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in *Gazette Extraordinary* No. 1813/ 24 of 07.06.2013 in respect of Sugar (HS. No. 17.01) is rescinded with effect from 2nd August 2013.
