The allotments of land depicted in Advance Tracing No. AM/MHO/2012/387 of 22.10.2012 prepared by the Surveyor-General situated in the Village of Nil-Oba (Topo.P.P.24), in Bintennapattu North Minor Division, in the Maha Oya Divisional Secretary's Division in Ampara District in Eastern Province and bounded as follows:
