NOTIFICATION MADE UNDER CLAUSE 154(C) READ WITH CLAUSE 154(F) OF THE CONSTITUTION

I, do hereby announce that the Schedule relating to enforcement of Entertainment Tax adopted by the Colombo Municipal Council on 30.07.2020 as per provisions stated under Sub-section 2(1) of the Entertainment Tax Ordinance No. 12 of 1946 amended by Entertainment Tax (Amendment) Act, No. 37 of 1984, the Schedule of which was approved by me as per powers entrusted in me according to the provisions stated under Subsection 2 (2) of the Entertainment Tax Ordinance read with Section 2 of the Provincial Councils (Consequential Provisions) Act, No. 12 of 1989 and the notification of such approval having been published in the *Gazette* Paper No. 2203/28 dated 26.11.2020 and included into the notification dated 18.11.2020 will be amended as stated in the Schedule hereto in compliance to the powers assigned to me under Clause 154 (c) of the Constitution read with Clause 154(f).

I would further announce that the above mentioned relevant amendments will be carried out for the public welfare based on the matters stated under regulations required to be followed when entertainment affairs are conducted; the regulations of which have been enforced in compliance to the provisions of The Quarantine and Prevention of Diseases Ordinance to control Covid - 19 epidemic owing to the impact caused by Covid - 19 epidemic to the area of authority of Colombo Municipal Council.



It is hereby notified further that until a regulation made again in this regard for year 2021 and 2022, the percentages stated in the undermentioned Schedule hereto shall be considered as the Entertainment Tax percentage to be charged by the Colombo Municipal Council for shows conducted in the Municipal Council area under Entertainment Tax Ordinance.
