SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Mahinda Rajapaksa, Minister of Finance, Economic and Policy Development of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodities specified in Column I of the Schedule hereto, a Special Commodity Levy at the rates specified in the corresponding entry in Column II of that Schedule.

This Order shall be valid for a period of six month (06 months) commencing from March 04, 2020 subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

The Order made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette Notification* No. 2143/3 of 30.09.2019 and the order made under Section 5 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette Notification* No. 2161/34 of 06.02.2020 in respect of Fish (HS Heading of 03.02, 03.03 and other than the Mackerel fish coming under HS Code 0303.54.00), are hereby rescinded with effect from March 04, 2020.
