NATIONAL WATER SUPPLY AND DRAINAGE BOARD ACT, No. 02 OF 1974

Order under Section 64(1)

BY virtue of the powers vested in me under Section 64(1) of the National Water Supply and Drainage Board Act, No. 02 of 1974, I Mahinda Rajapaksa, the Minister of Urban Development, Water Supply and Housing Facilities do by this order, embody in the schedule hereto the provision of the voluntary transfer scheme approved by me under Section 63(1) of the aforesaid law in respect of water supply undertakings carried on by the Bandarawela Municipal Council.

SCHEDULE

Section 61(1) – Contents in the Voluntary Transfer Scheme

- (a) Following movable and immovable properties to be vested to the National Water Supply and Drainage Board and be possessed by the Board. *i.e.:*



- (i) All lands, buildings, water pipes, all installations of all mechanical and electrical plant and machinery necessary in implementation and maintenance of intake, water towers, Break Pressure Tanks and Pumping House and all spares, standing equipment and stores necessary to maintain of machinery and equipment stated in the Schedules 01, 02, 03.
- (ii) The contracts whatsoever entered into by the Bandarawela Municipal Council with regard to the implementation and maintenance of water distribution system located within Bandarawela Municipal Council Limits and rights, liabilities, responsibilities of the Council be vested to the Board.
- (b) The contracts whatsoever entered into by the Bandarawela Municipal Council with regard to the planning, installations, construction, operations and maintenance with regard to the above property, as well as the rights, liabilities and responsibilities of the Council be vested to the Board.
- (c) All agreements entered into water consumers by the Bandarawela Municipal Council with regard to the use and supply of water services and payments to obtain such services will be vested to the Board.
- (d) The assets of these facilities valued at Rs. 7,320,850.00 (Rupees Seven Million Three Hundred and Twenty Thousand and Eight Hundred and Fifty) will be provide as a grant to the Board by the government.
- (e) All agreements entered into by the Municipal Council in connection with water supply will also be continued and honored by the board.

The above transfer will be effective from the Date of Publication of this Notice.
