**Notification made under Section 2 (2) of the Entertainment Tax Ordinance
bearing No. 12 of 1946**

I, Isura Devapriya, the Chief Minister of the Western Province and Minister of Finance and Planning, Engineering Services, Laws and Order, Local Government and Provincial Administration, Economic Promotion, Power and Energy Environmental Activities, Water Supply and Drainage and Tourism, do hereby notify that the Motion passed by the Colombo Municipal Council on 29.10.2018 as per the Provisions mentioned in the Section 2 (1) of the Entertainment Tax Ordinance bearing No. 12 of 1946 for the purpose of imposition and levy of the Tax for the years of 2019 and 2020 in the manner which is described in the following Schedule which shall be levied from the Admission Fee to be charged on entertainment activities declared in the Entertainment Tax Ordinance bearing No. 12 of 1946 amended by the Entertainment Tax (amendment) Act bearing No. 37 of 1984, was approved by me by virtue of the powers vested in me in terms of the provisions of the Section 2 (2) of the Entertainment Tax Ordinance bearing No. 12 of 1946 which shall be read together with the Section 2 of the Provincial Councils (Consequential Provisions) Act, bearing No. 12 of 1989.
