I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act as amended by the Land Acquisitions (Amendment) Act, No. 28 of 1964 that the Government intends to acquire the following lands for the widening and development of Kavinda Place in Kirulapone.

Description of the Land to be acquired :

Two (02) allotments of lands described in following name and total extents of 0.0379 Hectare depicted as Lot Nos. 1 and 2 in the Preliminary Plan No. CO 9820 dated 28th February, 2020 prepared by the Surveyor General situated in the village called Kirulapone, in the Thibirigasyaya Divisional Secretariat Divisions in Colombo District, Western Province within the Colombo Municipal Council limit and morefully described as follows:
