#### SCHEDULE

##### REVOCATION UNDER SECTION 39(1)

BY the Order under Section 38(a) of the Land Acquisition Act (Chapter 460) and published in the *Gazette Extra Ordinary* No. 1539/7 dated 03.03.2008, the land specified more fully in the Order No. 52 of 2008 dated 27.02.2008 was vested in the Democratic Socialist Republic of Sri Lanka.
