I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the State has required the land described below, located in either sides of the canal from Manel Mawatha to Andiris Mawatha for the development of Katu Ela under Werass Ganga Storm Water Drainage and Environment Improvement Project.
