**EXCISE (SPECIAL PROVISIONS) ACT, No. 13 OF 1989**

**Order under Section 3**

BY virtue of the powers vested in me by Section 3 of the Excise (Special Provisions) Act, No. 13 of 1989, as amended, I, Mahinda Rajapaksa, Minister of Finance, do by this Order declare that, the rate of Excise Duty specified in the Column IV applicable on corresponding articles specified in Columns I, II and III of the Schedule hereto, shall replace the rate specified in Column IV on the corresponding articles of the Schedule I of the *Extraordinary Gazette* Notification No. 2113/9 dated March 05, 2019 issued under the Section 3 of this Act with effect from August 22, 2020.
