TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2)(b) and Section 21(2)(b)

BY virtue of the powers vested in me by Section 6(2)(b) and Section 21(2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Mahinda Rajapakse, Minister of Urban Development, Water Supply and Housing Facilities, do by this Order-

- declare that the area of land specified in the Schedule hereto shall be an Urban Development Area for the purpose of the aforesaid Ordinance and shall be called "Embulgama Rajamaha Vihara Area";
- direct that an outline scheme shall be prepared for the area declared to be the Embulgama Rajamaha Vihara Area ;
and
- revoke the Order made under Sections 6(2)(b) and 21(2)(b) of the aforesaid Ordinance and published in the *Gazette Extraordinary* No. 1572/5 of October 20, 2008.
