01	Residential House or Commercial Shop (except 3rd category mentioned below)	Rs. 50.00 per week
02	Factories	Rs. 20.00 per day
03	Canteens, Food Stalls, Banana Stalls, Beef Stalls, Mutton Stalls, Chicken Stalls, Fish Stalls	Rs. 5.00 per Kg
04	Used king coconut husks (it should be cut into two halves and handed over)	Rs. 01.00 each
