ORDER UNDER SECTION 39A(1)

THE allotments of land specified in the Order No. 105 of 1992 made under the Proviso (a) to Section 38 of the Land Acquisition Act, (Chapter 460) and published in the *Gazette Extra Ordinary* No. 725/28 dated 31st July 1992 and revising the said order, the allotments specified in the Correction Paper to the Order No. 105 of 1992 published in the *Gazette Extra Ordinary* No. 747/12 dated 30th December 1992, are vested absolutely in the State and the possession of which has been taken for or on behalf of the State under Para (a) of Section 40 of the aforesaid Act.
