THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

My Ref. No: ARA/LND/ACQVI/D3/30.
Land Ministry's Ref. No: 4-3/15/2016/VE/400.

I, Samarakoon Mudiyanseelage Chandrasena, Minister of Lands do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

An allotment of land which Names, extent and boundaries are mentioned below is depicted in advance tracing No. KE/ARN/2016/353 and dated 07.12.2016 made by the Survey General and situated in the village of Kalugala, in the Grama Niladari Division of 47D Kalugala, in the Minor Division of Ganhatha Palatha, in the Divisional Secretariat Division of Aranayaka, in the District of Kegalle, in Sabaragamuwa Province.

1. Lot A – Extent : 0.0303 Hectare

North and East: Debathgamawatta (Part of Kalugala); South: Lot B; West: Lot B and Debathgamawatta (Part of Kalugala).

2. Lot B – Debathgamawatta (Part of Kalugala) - Extent : 3.6660 Hectare

North: Road Delgolle Pilideniye Henyaya Debathgamawatta (Part of Kalugala) and Lot A; East: Debathgamawatta (Part of Kalugala) and Road; South: Debathgamawatta (Part of Kalugala) Kalugalawatta and Lot C; West: Lot C and Delgolle Pilideniye Henyaya.

3. Lot C – Extent : 0.1673 Hectare

North: Delgolle Pilideniye Henyaya and Lot B; East: Lot B Kalugalawatta; South: Kalugalawatta and Lot K; West: Lots K, F and E.

4. Lot D – Road - Extent : 0.0076 Hectare

North: Delgolle Pilideniye Henyaya and Lot C; East: Lots C and E; South: Lot E and Delgolle Pilideniye Henyaya; West: Delgolle Pilideniye Henyaya.



5. Lot E - Debathgamawatta (Part of Kalugala) - Extent : 0.3353 Hectare

North: Lots D and Lot C; East: Lot C; South: Lot F and Degolle Pilideniye Henyaya; West: Delgolle Pilideniye Henyaya and Lot D.

6. Lot F - Extent : 0.0109 Hectare

North: Lot E; East: Lots E and C; South: Lot K and Degolle Pilideniye Henyaya; West: Delgolle Pilideniye Henyaya.

7. Lot G - Pilideniye Henyaya - Extent : 0.0049 Hectare

North: Pilideniye Henyaya; East: Pilideniye Henyaya and Lot K; South: Lots K and H; West: Lot H and Pilideniye Henyaya.

8. Lot H - Extent : 0.0594 Hectare

North: Pilideniye Henyaya Lots G and K; East: Lot K; South: Lot K stream and abandoned Tea land; West: Lot M and Kalugalawatta.

9. Lot K - Debathgamawatta (Part of Kalugala) - Extent : 5.4667 Hectare

North: Lot G Pilideniye Henyaya Delgolle Pilideniye Henyaya and Lot F; East: Lot C and Kalugalawatta; South: Stream; West: Lot H.

10. Lot M - Debathgamawatta (Part of Kalugala) - Extent : 0.9723 Hectare
