Delegation of Powers by the Public Service Commission in terms of Article 57 (1) of the Constitution

THE delegation of powers by the Public Service Commission in terms of Article 57(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka published in the *Gazette Extraordinary* No. 2014/3 dated 11.04.2017 as amended by the *Gazettes Extraordinary* No. 2131/60 dated 13.07.2019, No. 2074/45 dated 08.06.2018 and No. 2043/13 dated 30.10.2017 is amended as follows. This amendment shall come into effect from 03.08.2021.
