THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Samarakoon Mudiyansele Chandrasena, Minister of Lands, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land depicted in the Advance Tracing No. CO/KTT/2020/609 dated 01.02.2021, prepared by the Surveyor General, situated in the Village called Welikada in the Grama Niladhari's Division of 514 B, Rajagiriya within the limits of Sri Jayawardenepura Kotte Municipal Council in the Divisional Secretary's Division of Sri Jayawardenepura Kotte in Colombo District, Western Province and bounded as follows:

01. Lot No. 1 – Assmt. No. 300, Sri Jayawardenepura Mawatha – Extent: 1.0012 Hectare

North: Land bearing Assmt. No. 294, Sri Jayawardenepura Mawatha and Sri Jayawardenepura Mawatha; East: Sri Jayawardenepura Mawatha and Kotte canal; South:

Kotte canal, Cement drain and Lot No. 2; West: Cement drain, Lot No. 2 and land bearing Assmt. No. 294, Sri Jayawardenepura Mawatha.

02. Lot No. 2 – Assmt. No. 953/1, Sri Jayawardenepura Mawatha – Extent: 0.1336 Hectare
