THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Samarakoon Mudiyansele Chandrasena, Minister of Lands, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land in total extent of about 1.3493 Hectares, depicted as Lots 'A' and 'B' in the Advance Tracing No. B/HLE/2019/495 dated 31.12.2019, prepared by the Surveyor General, situated in the Village of Kurukude (F.V.P. 14) in the Grama Niladhari Division of Kurukude (57 C) in the Minor Division of Dehivinipalatha Korale in the Divisional Secretary's Division of Hali-Ela in Badulla District, Uva Province and bounded as follows:
