**TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)**

**Order under Section 6(2)(b) and Section 21(2)(b)**

BY virtue of the powers vested in me by Section 6 (2)(b) and Section 21(2) (b) of the Town and Country Planning Ordinance (Chapter 269), I, Mahinda Rajapaksa, Minister of Urban Development and Housing do by this Order,

01. Declare that the area of land called “Mampita Walagamba Purana Gallen Raja Maha Vihara Area” specified in the Schedule hereto shall be an Urban Development Area for the purpose of the aforesaid Ordinance; and
02. Direct that an outline physical plan shall be prepared for the “Mampita Walagamba Purana Gallen Raja Maha Vihara Area” which is to be declared as an urban development area.
